## DREDGING PERMIT

APPLICANT:

Sonoma County Regional Parks 2403 Professional Drive, Suite 100 Santa Rosa, California 95403

## AREA, TYPE LAND AND LOCATION:

Granted lands in Bodega Bay at Bodega Harbor, Sonoma County subject to a reserved mineral interest.

LAND USE:

In cooperation with the U.S. Army Corps of Engineers, dredge a maximum 44,203 cubic yards of material to maintain a navigable depth in the channel and at six existing marinas in the harbor. The dredged material will be permanently disposed of at the approved "old airport" disposal site. As a condition applicant's Coastal Commission permit, the disposal site will be restored, the levees strengthened and a public access walkway established. Certain title issues remain to be resolved between the County and the State Lands Commission (SLC) regarding the disposal site. SLC staff maintains that it is granted sovereign lands. The County holds title to a portion of the site as proprietary lands. The County has represented that it will make a good faith effort to resolve the title questions in a timely manner. Based on that representation, Staff recommends approval of this permit.

TERMS OF PROPOSED PERMIT:

Initial period:

One (1) year beginning June 6, 1991.

Royalty:

No charge because the project is for public benefit. \$0.25 per cubic yard for material used for commercial or private benefit purposes.

A FEE OF \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR MATERIAL USED FOR PRIVATE BENEFIT OR COMMERCIAL SALE PURPOSES. THE PERMITTED ACTIVITY IS CONTINGENT UPON THE APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE, AND LOCAL GOVERNMENT AGENCIES.
