APPROVE THE SECOND MODIFICATION OF THE 1991-92 PLAN OF DÉVELOPMENT AND OPERATIONS AND BUDGET LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY PROPOSING TRANSFER OF FUNDS

The City of Long Beach has submitted for Commission approval the Second Modification of the 1991-92 Plan of Development and Operations and Budget, Long Beach Unit, covering the period July 1, 1991 through June 30, 1992, proposing the transfer of \$1,100,000 within the Oil and Gas Production Program. This transfer of funds is in accordance with the provisions of Part IV, Section A, of the 1991-1992 Plan and Budget.

This transfer will increase Account No. 24-916, Gas Treating by the amount of \$1,100,000. The City of Long Beach is requesting this additional amount to fund the repair of the JL-2 gas shipping line which was not included in the 1991-92 Plan and Budget. The funds will be transferred from Account No. 21-942 Oil Well Workover. The adjusted budget for Account No. 21-942 is presently \$4,100,000.

The funds remaining in the Oil Well Workover Account after the transfer will be \$3,000,000 which will be insufficient to fund the projects originally budgeted.


