## TERMS OF ORIGINAL PERMIT:

Initial period:

## Consideration:

## OTHER PERTINENT INFORMATION:

1. At its March 24, 1983 meeting, Minute Item 15, the Commission authorized the issuance of a General Permit - Recreational Use to Ilia G. Poppoff, Betty S. Poppoff, Oleg N. Obuhoff and Ruth Obuhoff for the subject facilities in Lake Tahoe. The lessees owned adjacent single-family residences on the littoral upland and jointly shared the use and maintenance of the subject pier. This transaction is precipitated by the conveyance of all the Assignor's interest in the littoral upland and the subject leasehold interest (50%) to the Assignee.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.


