OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

2. PRC 5743 was previously approved at the State Lands Commission May 1, 1991 meeting as Item C02, Item F on Exhibit "A", for continued use and maintenance of an existing floating dock. Staff has determined that the upland property description is incorrect and needs to be amended to read as follows:

A portion of Lot 1, Subdivision No. 12 of Los Molinos Land Company.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY P.R.C. 21065 AND 14 CAL. CODE REGS. 15378.
2. AMEND PRC 5743 SO THAT THE UPLAND PROPERTY DESCRIPTION READS AS FOLLOWS: A PORTION OF LOT 1, SUBDIVISION NO. 12 OF LOS MOLINOS LAND COMPANY.
3. ALL OTHER TERMS AND CONDITIONS OF THIS PERMIT REMAIN IN FULL FORCE AND EFFECT.
4. AUTHORIZE STAFF TO TAKE ALL NECESSARY ACTIONS TO EFFECT THE COMMISSION'S ACTION.

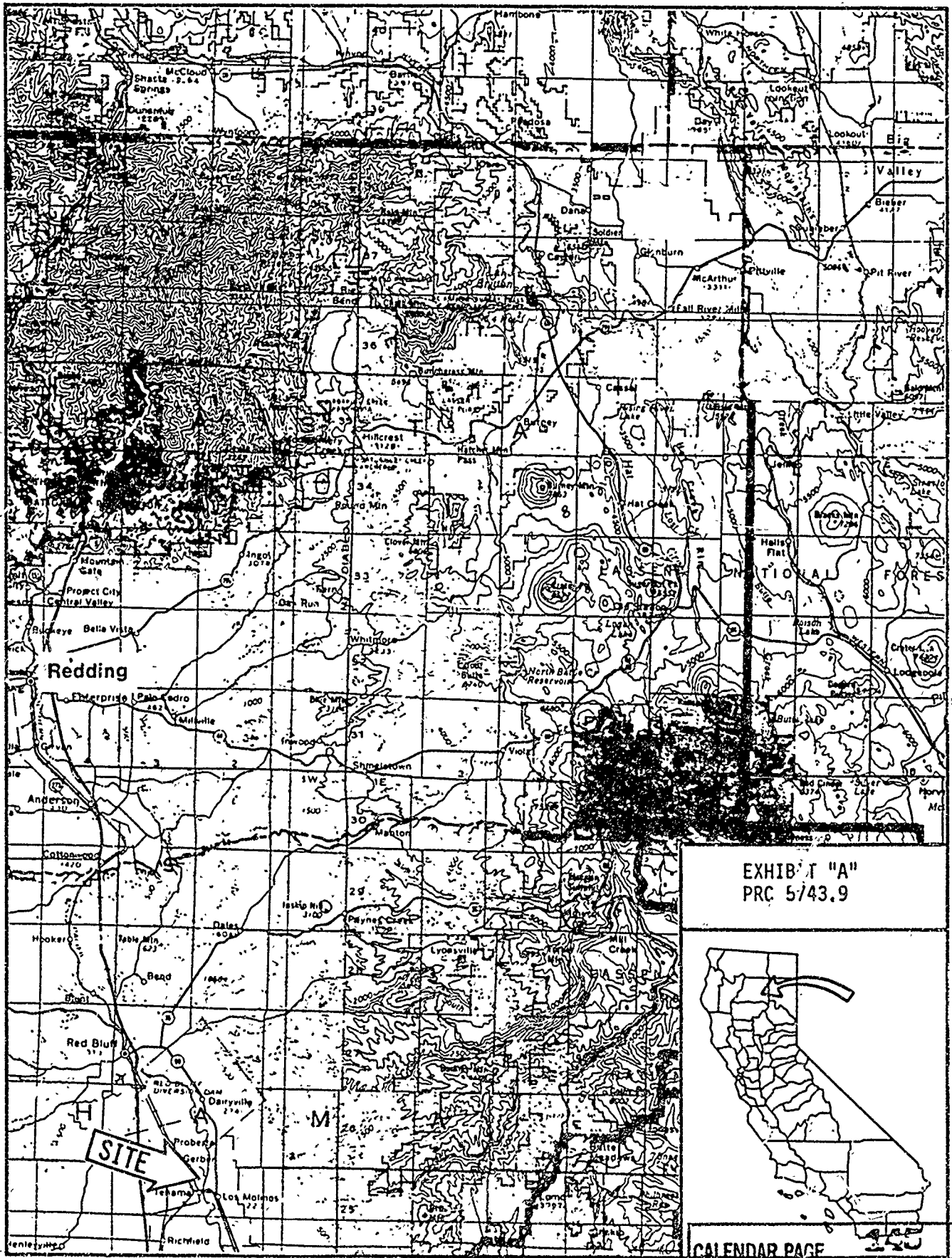
