AREA, TYPE LAND AND LOCATION:

Three parcels of school land located three miles northwest
of the city of Santa Cruz, collectively known as Scaroni
Ranch.

LAND USE:

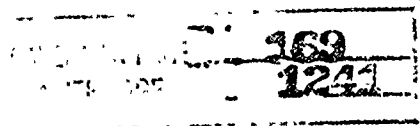
PRC 5367: a 134-acre parcel used for row-crop farming;
PRC 5368: an 84-acre parcel used for row-crop farming; and
PRC 5369: a 440-acre parcel used for grazing.

TERMS OF LEASE RENEWALS:

Initial period:
One year beginning January 1, 1992 with same terms as
prior leases.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Fees and expenses for PRC 5367, \$29,480; PRC 5368, \$18,040;
and PRC 5369, \$4,453 have been received.

OTHER PERTINENT INFORMATION:

1. Lessees' current leases for cattle grazing and farming expired on December 31, 1991 and Lessees desire to continue to lease the property for the same use.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 2 Cal. Code Regs. 2905(d)(1).

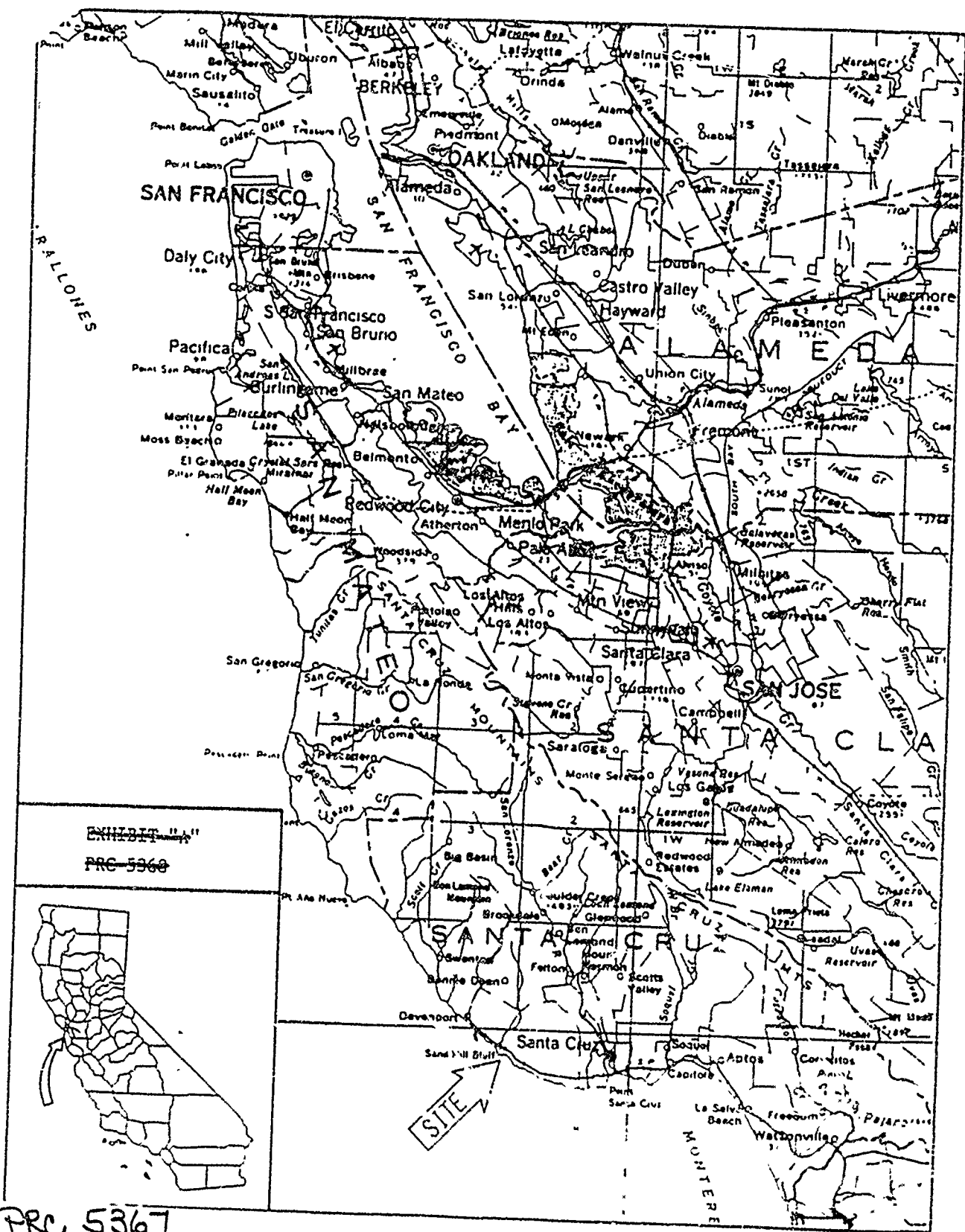
