GENERAL LEASE - RIGHT-OF-WAY USE

APPLICANT:

Tosco Refining Company, a Division of Tosco Corporation Avon Refinery Martinez, California 94553

AREA, TYPE LAND AND LOCATION:

A 0.04-acre parcel of tide and submerged land in Taylor Slough between Bethel Island to Jersey Island, Contra Costa County.

2. Prior to construction, lessee shall provide a map showing the location of the nearest block valve upstream of the slough together with a narrative description of leak detection and emergency shutdown procedures in the event of a pipeline rupture in the slough.

3. Lessee shall provide a certified copy of the final hydrotest results upon completion of construction.

4. Lessee shall provide an "as built" plan of the Taylor Slough pipeline crossing showing horizontal alignment data and vertical grades, certified by a licensed surveyor. This information is to be provided within 60 days after the project has been accepted as complete by Tosco.

5. Lessee shall provide details of the annual pipeline inspection procedures to be performed, and copies of the annual inspection reports.

6. Lessee shall immediately notify lessor, in writing, in the event of any planned repairs or modification of the pipeline in the crossing.

7. In the event that any cultural artifacts or remains are uncovered during the trenching operations in Taylor Slough, lessee will immediately cease operations and notify lessor.

CONSIDERATION:

\$100 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

#### OTHER PERTINENT INFORMATION:

- 1. A Negative Declaration, SCH 92033052, was prepared and adopted for this project by the County of Contra Costa. The State Lands Commission's staff has reviewed the information contained therein.
- 2. The Applicant proposes to extend an underground gas pipeline along Canal Road from an existing gas vell on Bethel Island. The pipeline would extend west across Taylor Road and Taylor Slough. The new line, approximately 3,500 feet in length, will connect to an existing pipeline which runs along Jersey Island Road. The only State lands affected by this project consists of the crossing of Taylor Slough at an existing utility crossing which is about 340 feet wide at this location.
- 3. Impacts to State-owned lands which may result from this proposed project include the following: water quality, soil disturbance, minor vegetation disturbance from trenching activities, and potential impacts to Delta Smelt, Winter Run Chinook Salmon, and other inland fisheries.

The Department of Fish and Game has issued its Streambed Alteration Agreement which conditions mitigate for the above impacts, including the construction window of August through September. In addition, the U.S. Fish and Wildlife Service has imposed a construction window of July 1, to November 30, 1992 to avoid impacts to Delta Smelt.

The conditions imposed by the above agencies, along with the proposed conditions in the State Lands Commission lease will ensure that the identified impacts are properly addressed.

Contra Costa County did not adopt a monitoring program for this proposed project, as they determined that the identified impacts were reduced to a level of insignificance due to the conditions imposed by other regulatory authorities.

4. This activity involves lands identified as possessing significant environmental values pursuant to F.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.






