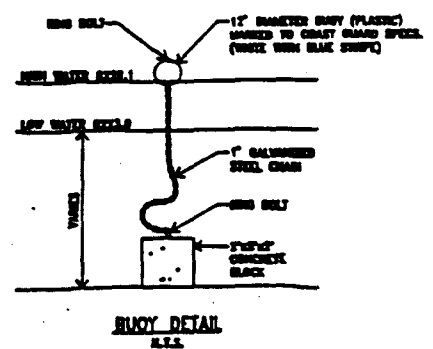
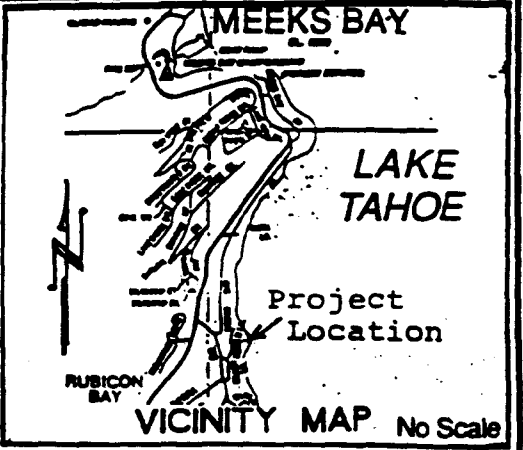
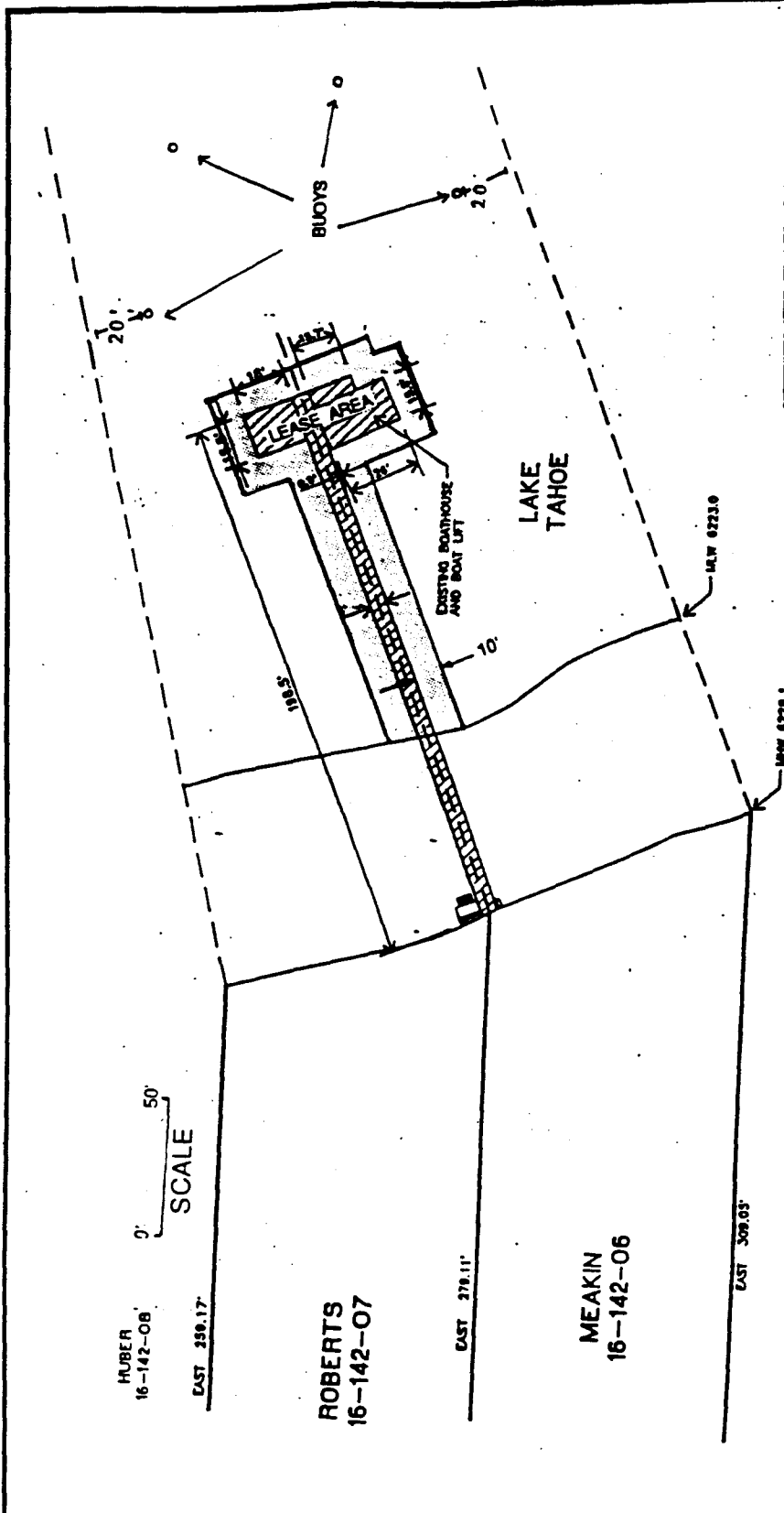
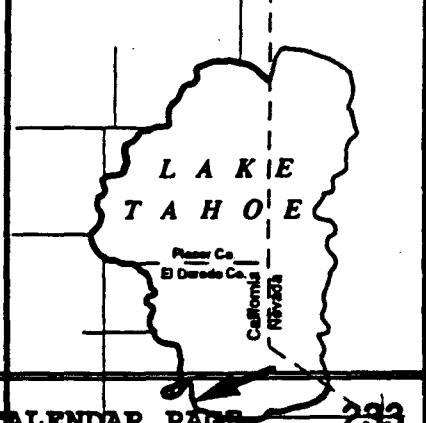


EXHIBIT "A"
