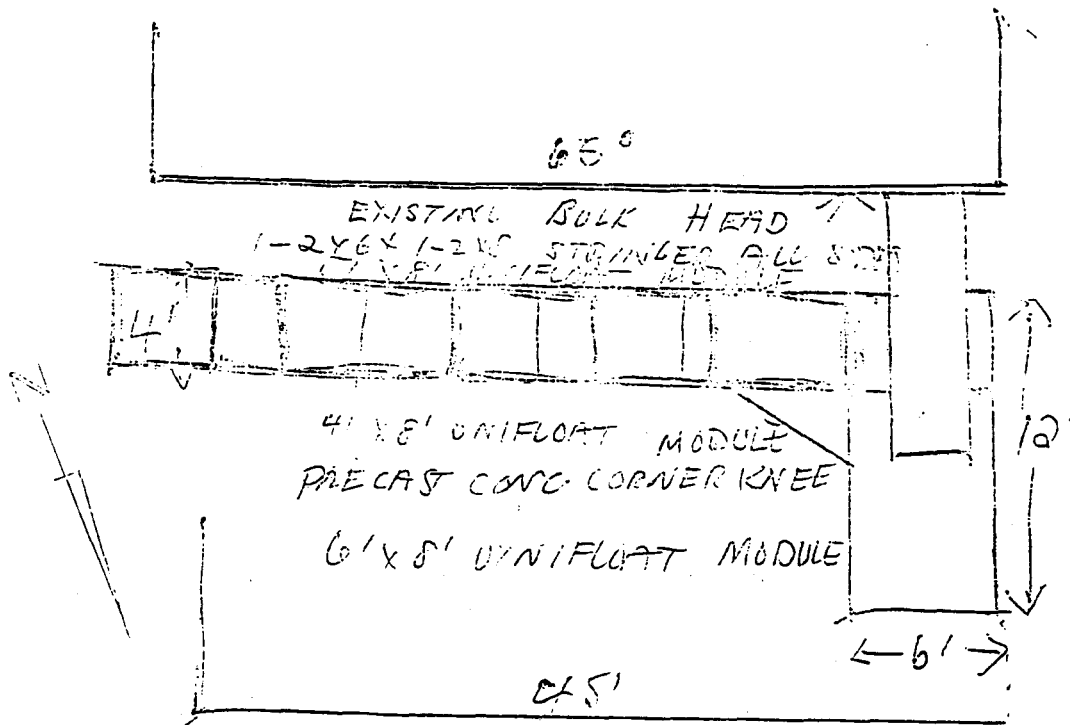

LOCATION MAP

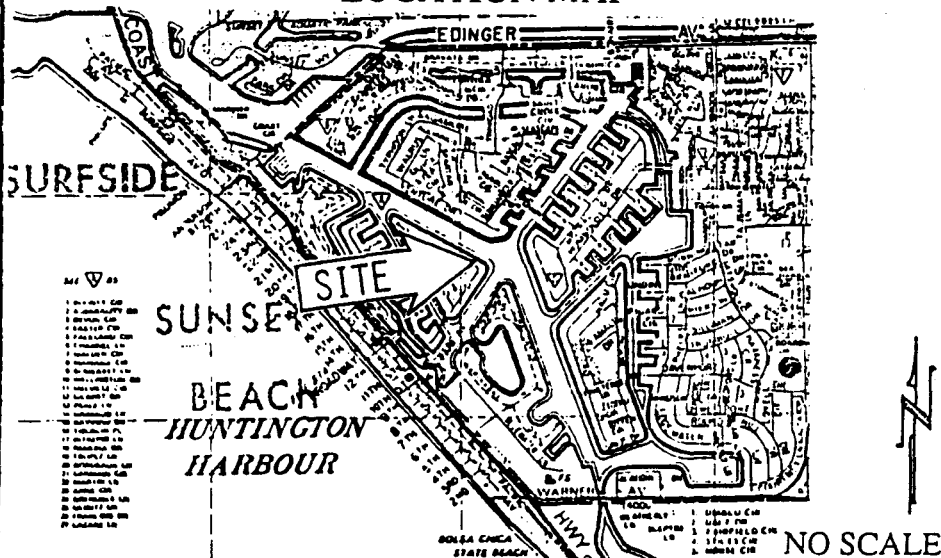
