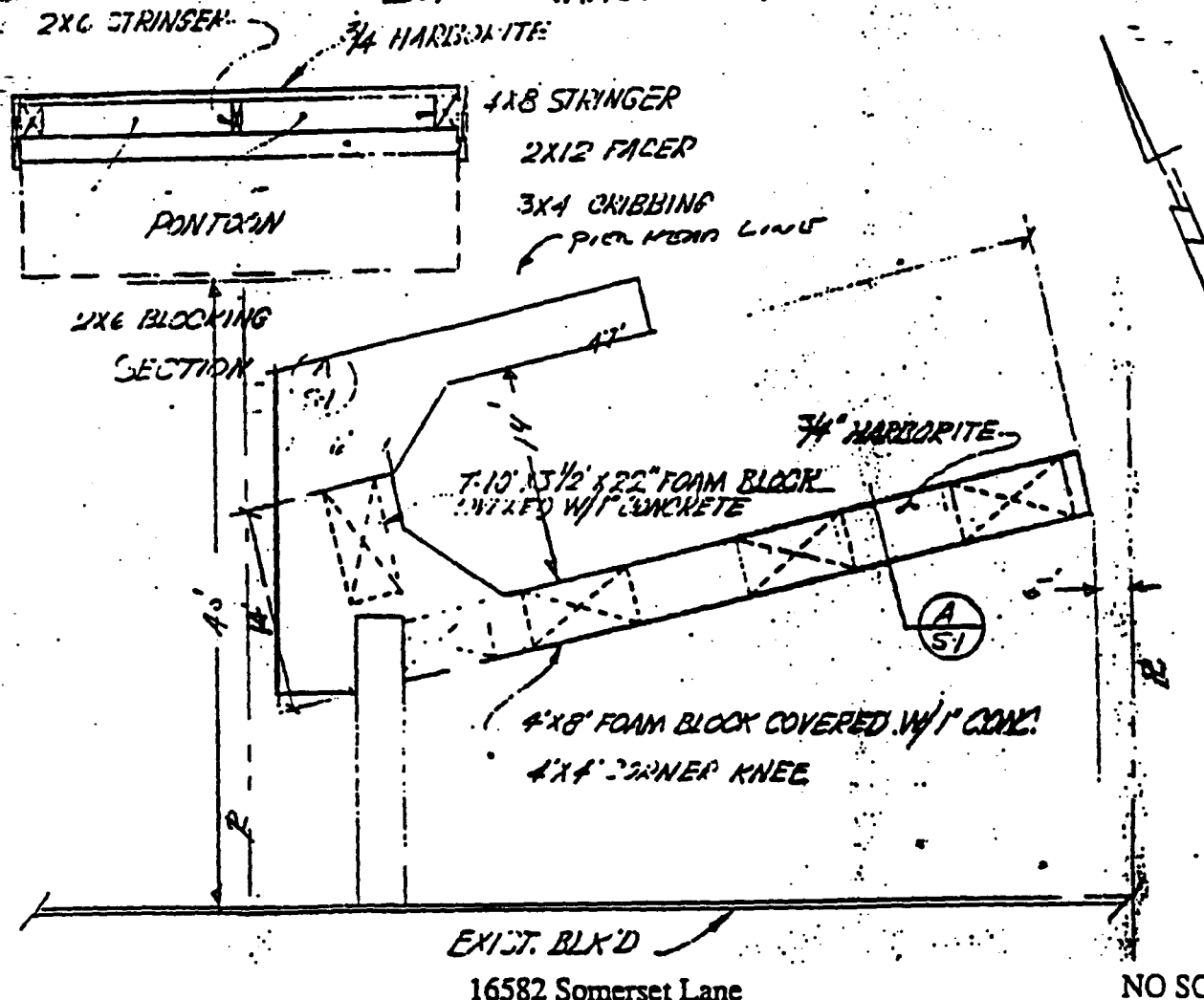

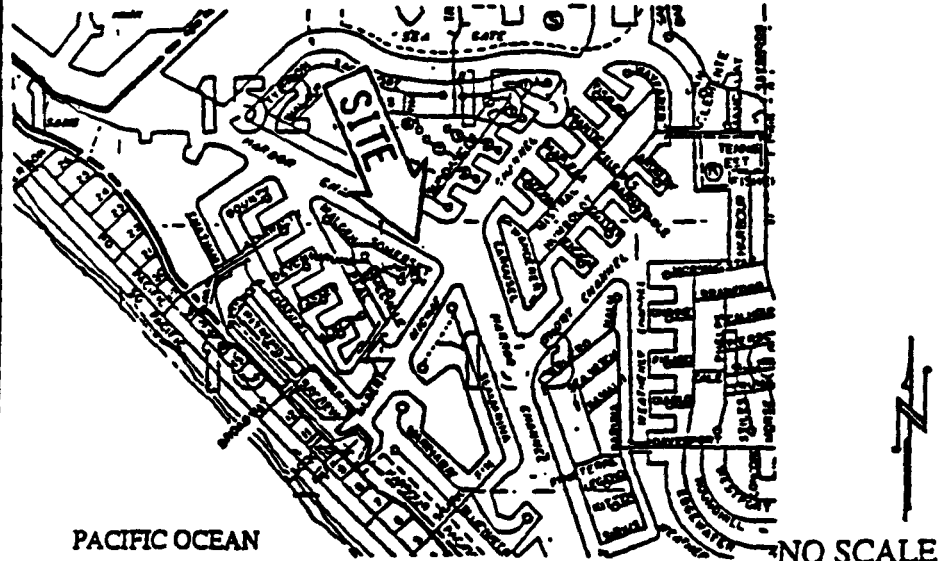


EXIST. BLK'D
