APPROVE THE PARTIAL ASSIGNMENT OF STATE OIL AND GAS LEASES
PRC 714 AND PRC 729, RIVER ISLAND,
SACRAMENTO AND SAN JOAQUIN COUNTIES

AREA, TYPE LAND AND LOCATION:

Oil and gas leases PRC 714 and PRC 729 contain tide and submerged land encompassing portions of the Sacramento River, Georgiana Slough, and the North Fork of the Mokelumne River in Sacramento and San Joaquin Counties.

BACKGROUND:

Oil and gas leases PRC 714 and PRC 729 were issued to Brazos Oil and Gas Company on April 18, 1956, and June 30, 1956, respectively. Through a series of assignments, Union Oil Company of California (Unocal) holds an undivided one-half interest in PRC 714 and PRC 729. Casex Company (Casex) holds an undivided one-half interest in PRC 714 and PRC 729 and is the operator.

Paragraph 4 of gas leases PRC 714 and PRC 729 provides, in part, that the lease may not be assigned except with the written consent of the State, and then only to a corporation, who at the time of the proposed assignment, possesses the qualifications provided in Division 6 of the Public Resources Code.

In a letter dated January 26, 1995, Enron Oil and Gas Company (Enron) requested approval of the assignment from Unocal to Enron of all of Unocal's right, title and interest in PRC 714 and PRC 729.

Commission staff has reviewed the financial documents submitted by Enron and has found Enron to be qualified under P.R.C. 6801 and P.R.C. 6804 to hold the lease. The bond requirements of each lease has been fulfilled by the Assignee, and the forms of assignment have been executed by Unocal (Assignor) and by Enron (Assignee).

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Filing fee, processing costs have been received.

Separate performance bonds, each in the sum of \$25,000 have been received for PRC 714 and PRC 729.

2. APPROVE THE ASSIGNMENT TO ENRON OIL & GAS COMPANY OF UNION OIL COMPANY OF CALIFORNIA'S UNDIVIDED ONE-HALF INTEREST IN PRC 714 AND PRC 729. THE ASSIGNMENT SHALL NOT RELEASE THE ASSIGNOR FROM ANY OBLIGATION TO THE COMMISSION UNDER THE ORIGINAL AGREEMENT AND LEASES, AND THE ASSIGNEE SHALL BE BOUND BY THE AGREEMENT AND LEASES, INCLUDING ANY MODIFICATIONS AND COLLATERAL AGREEMENTS, TO THE SAME EXTENT AS THE ASSIGNOR, ANY CONDITION IN ANY ASSIGNMENT AGREEMENT TO THE CONTRARY NOTWITHSTANDING. THIS ASSIGNMENT WILL TAKE EFFECT ON THE FIRST DAY OF THE MONTH FOLLOWING COMMISSION ACTION.

3. AUTHORIZE THE STAFF TO EXECUTE ANY DOCUMENTS NECESSARY TO CARRY OUT THE COMMISSION'S ACTION.

All of those tide and submerged lands lying northerly and westerly of a line drawn midway between the centerlines of the existing channels of the Sacramento River and Georgiana Slough within the limits of the following described tract:

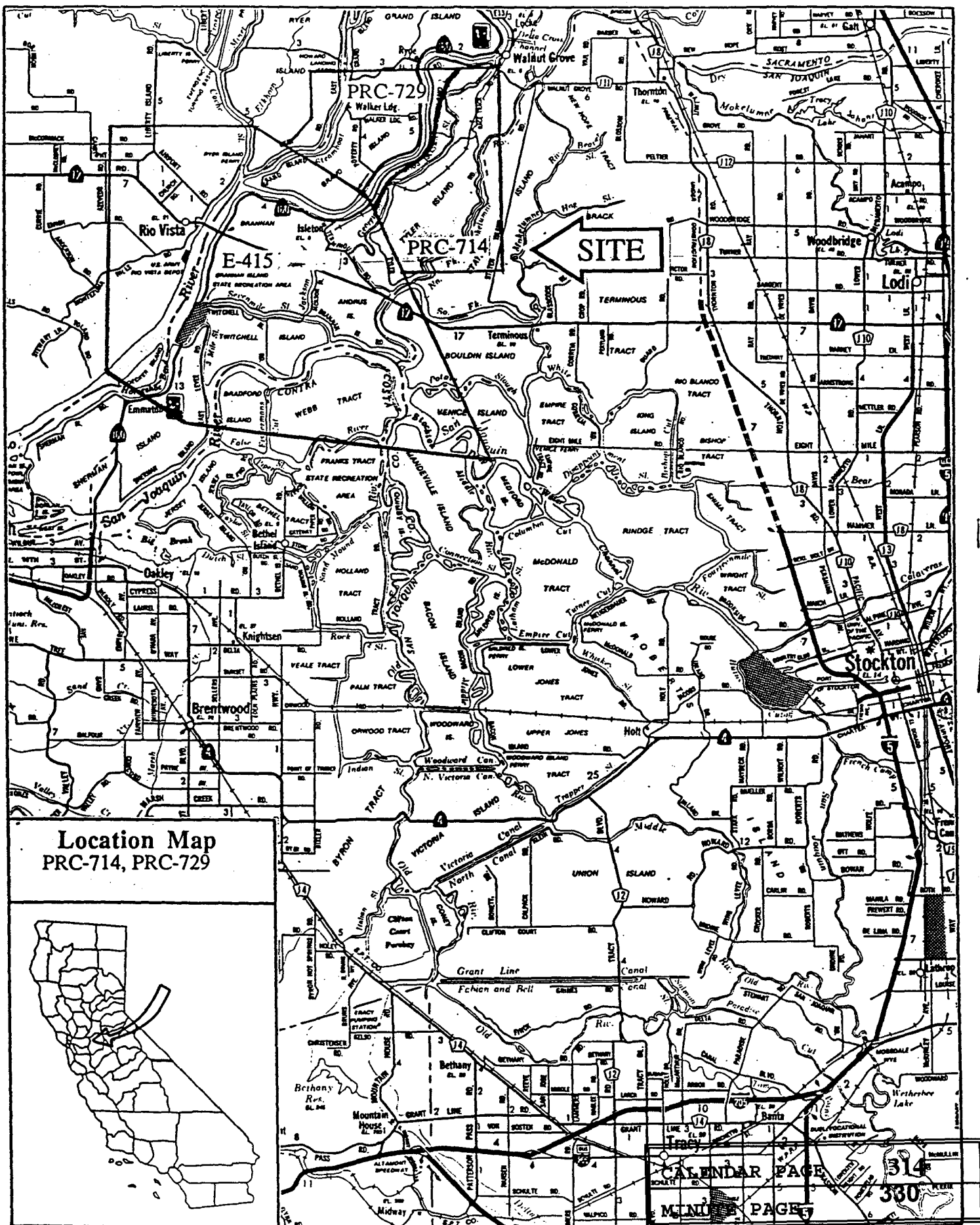
