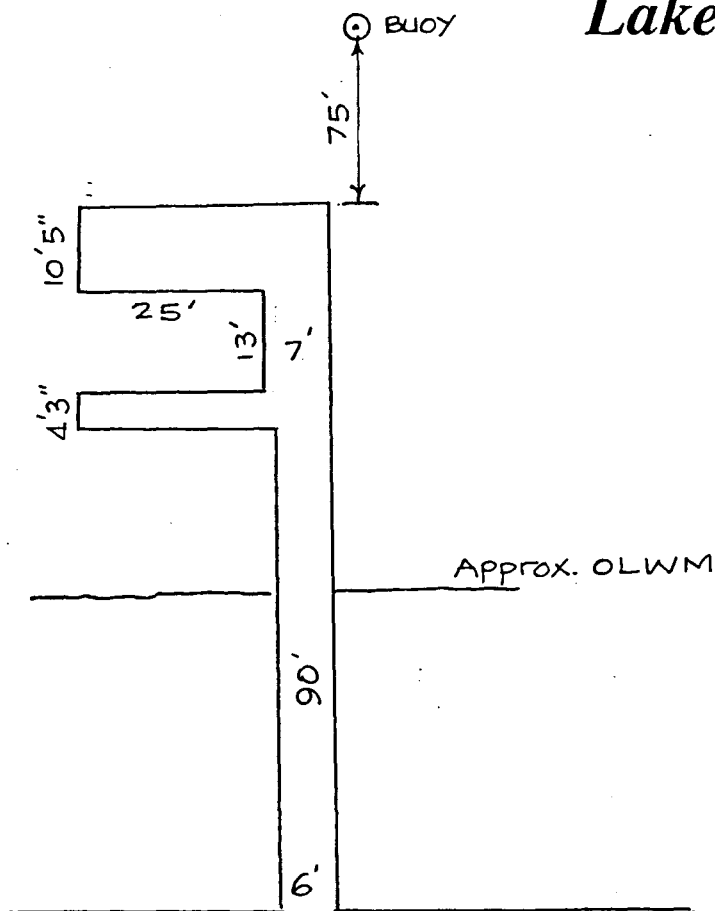

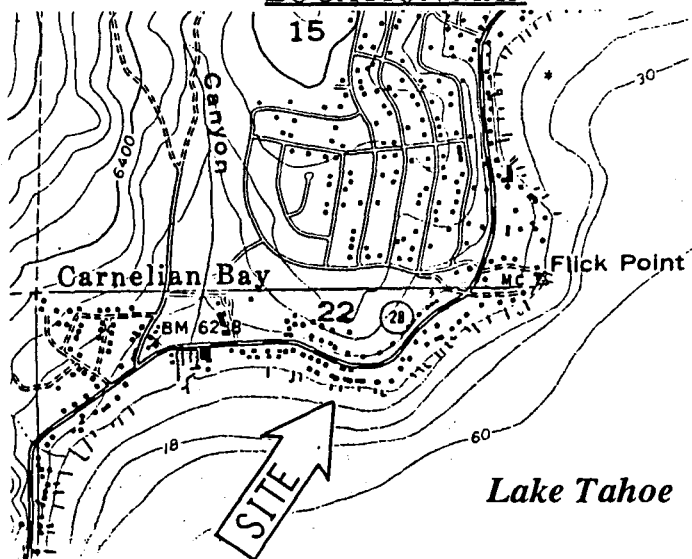
Lake Tahoe

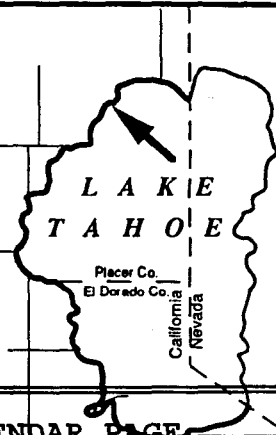
LOCATION MAP
