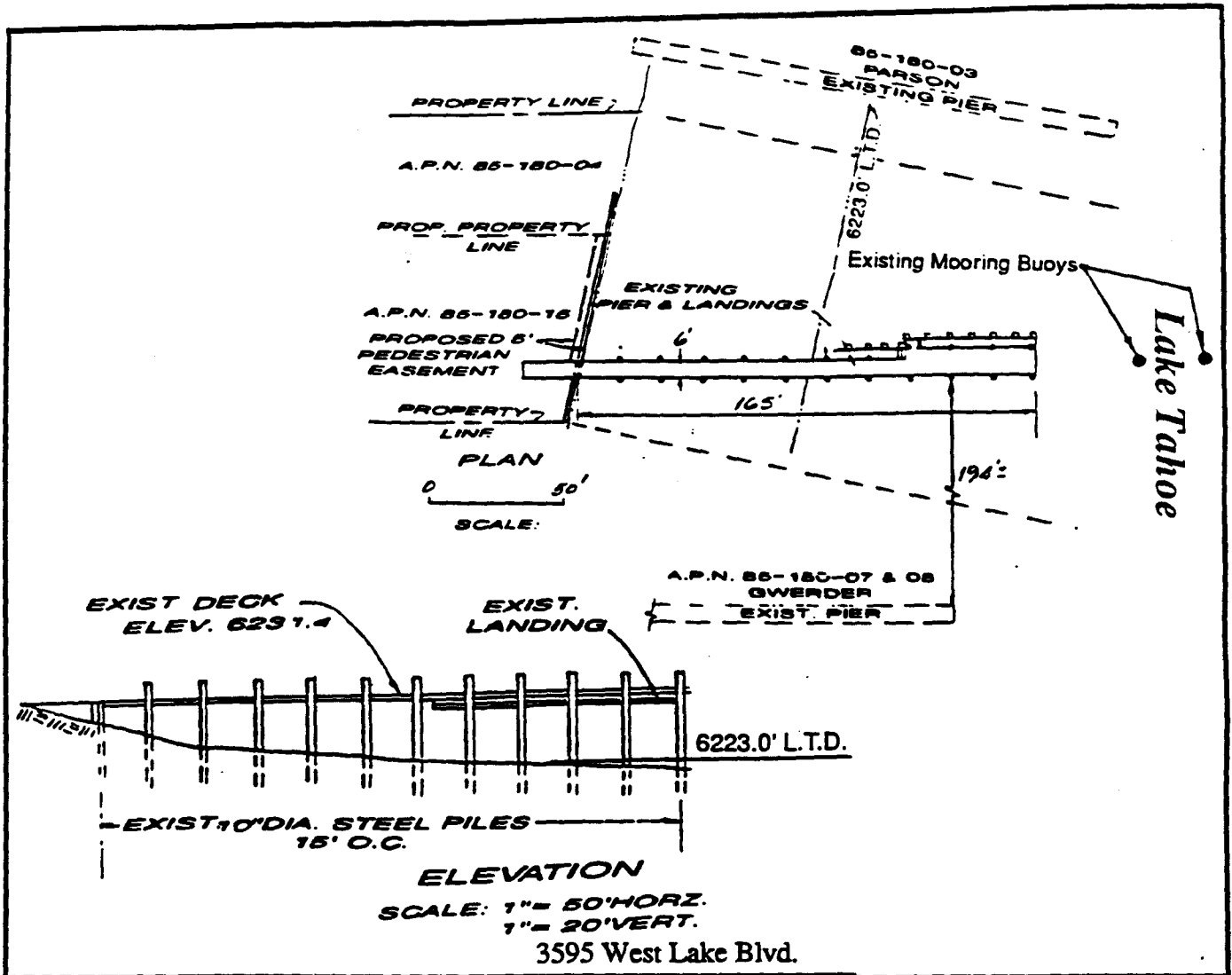

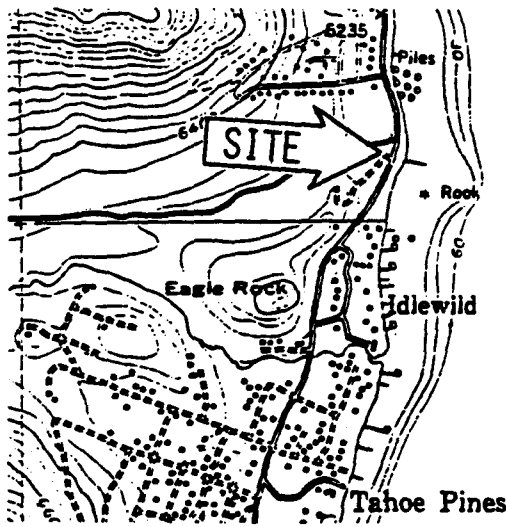

LOCATION MAP

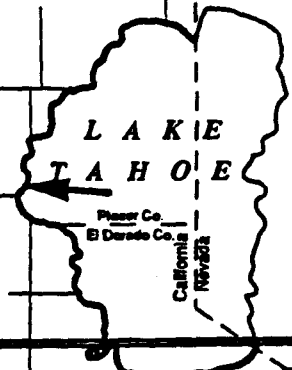


Lake Tahoe

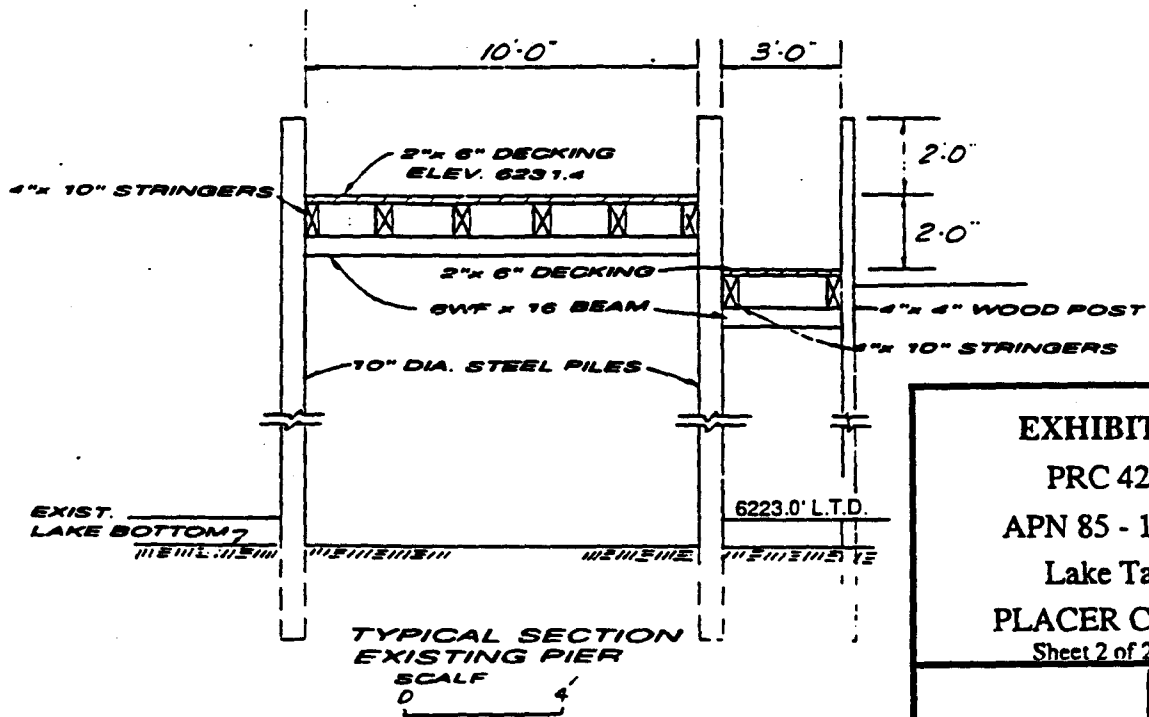
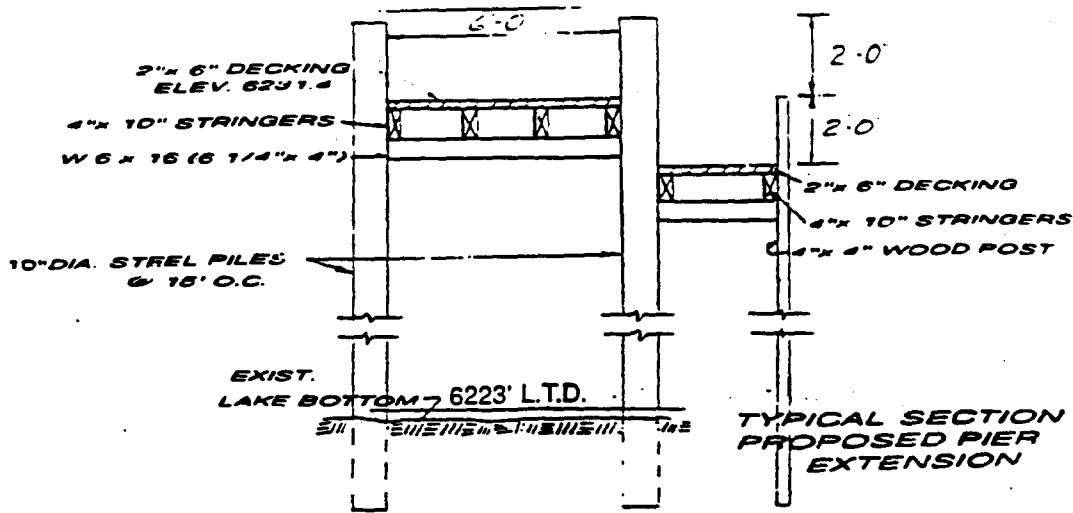
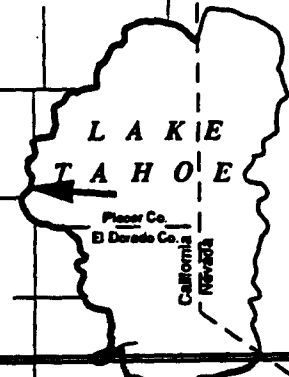
