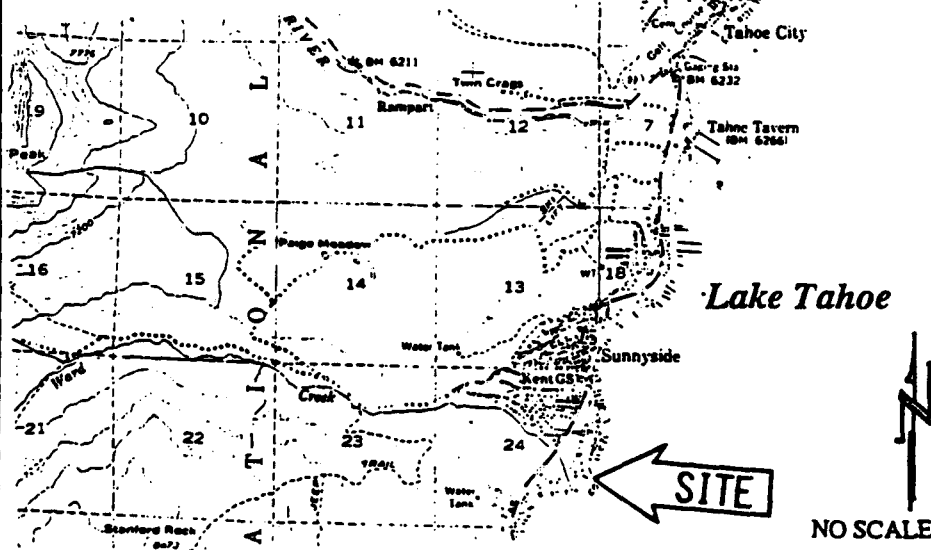
Lake Tahoe



2380 SUNNYSIDE LANE.

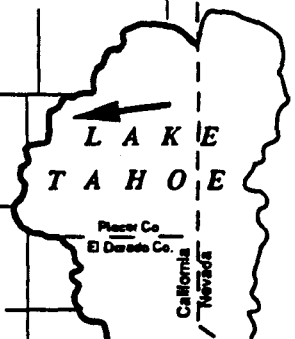
