RECREATIONAL PIER LEASE

A parcel of submerged land located in the bed of Lake Tahoe
at Tahoma, Placer County.

OTHER PERTINENT INFORMATION:

1. This lease authorizes the reconstruction of an existing pier, construction of a low level boatlift, retention of an existing marine rail and retention of two existing mooring buoys.
2. The lease is conditioned on lessee obtaining authorization from the Tahoe Regional Planning Agency for the existing buoys within two years of the effective date of the lease.

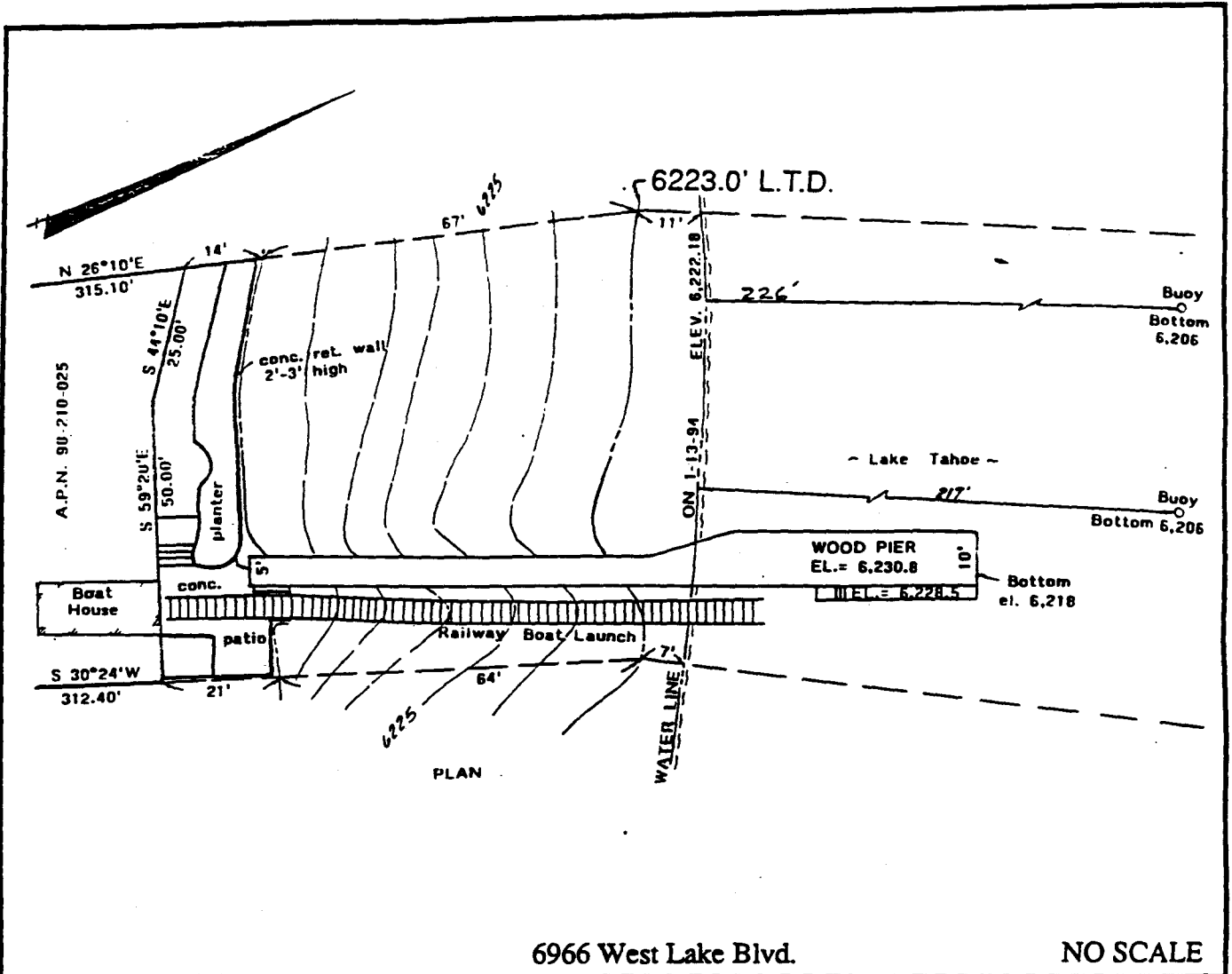

LOCATION MAP

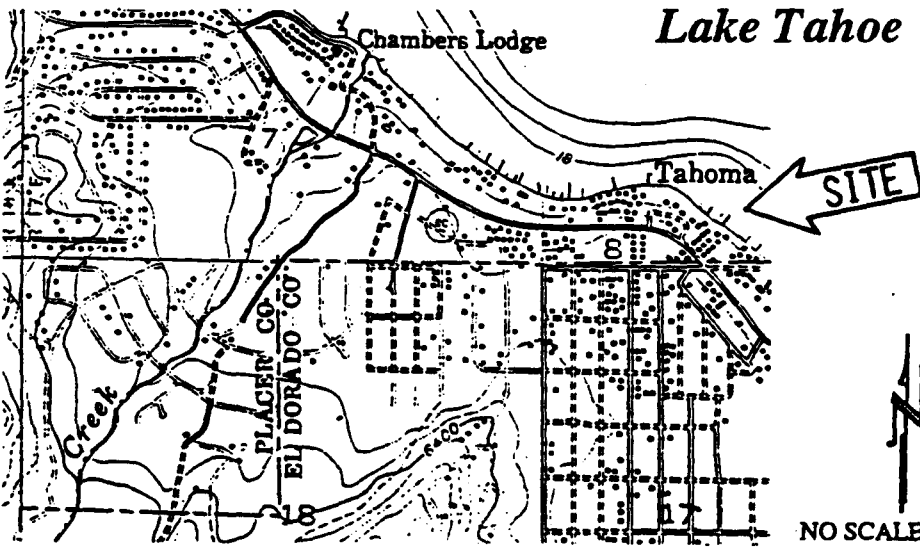
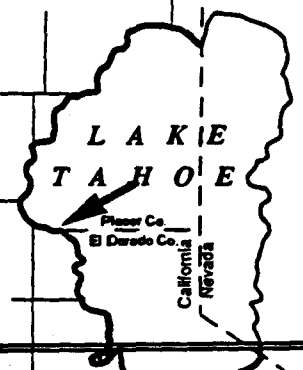
