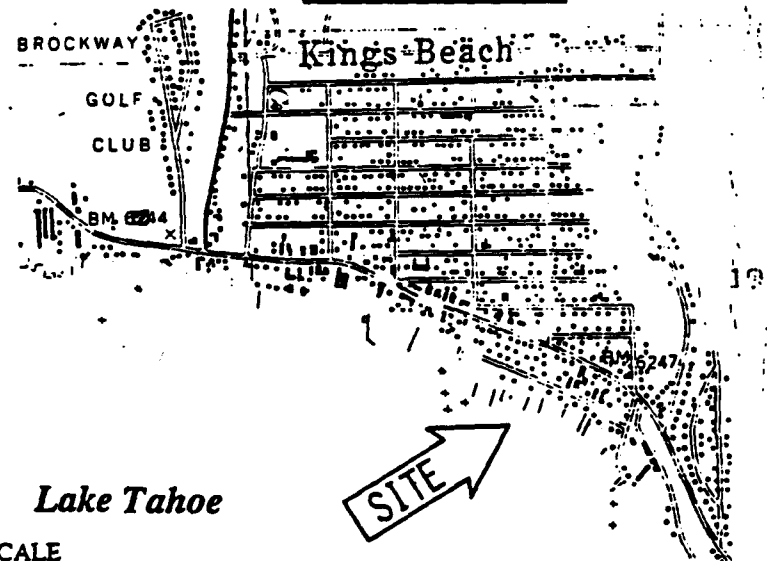
BOATLIFT DETAILS

LOCATION MAP

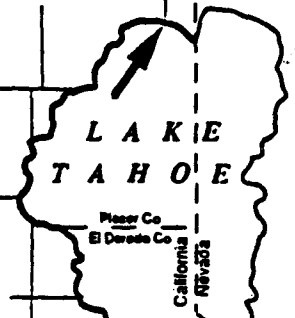
