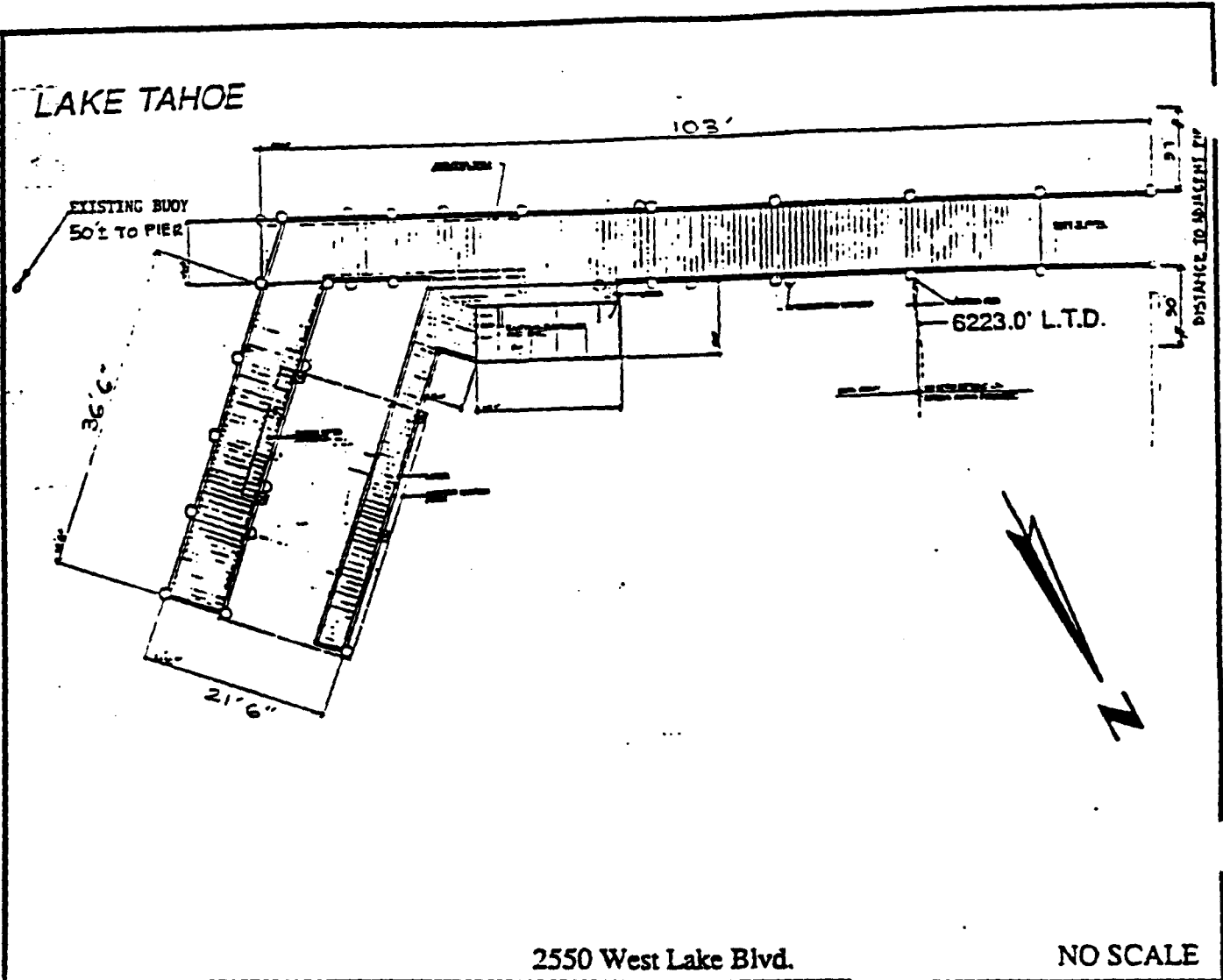

LOCATION MAP

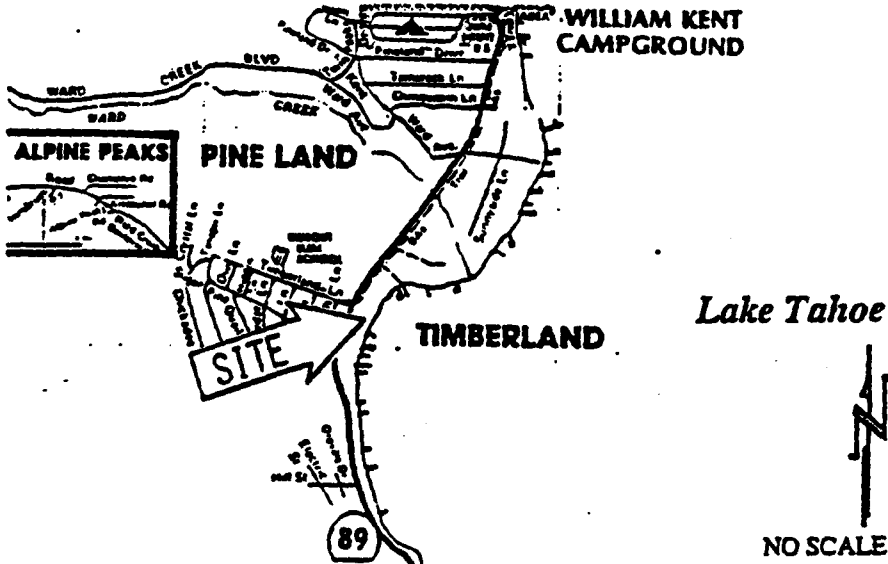

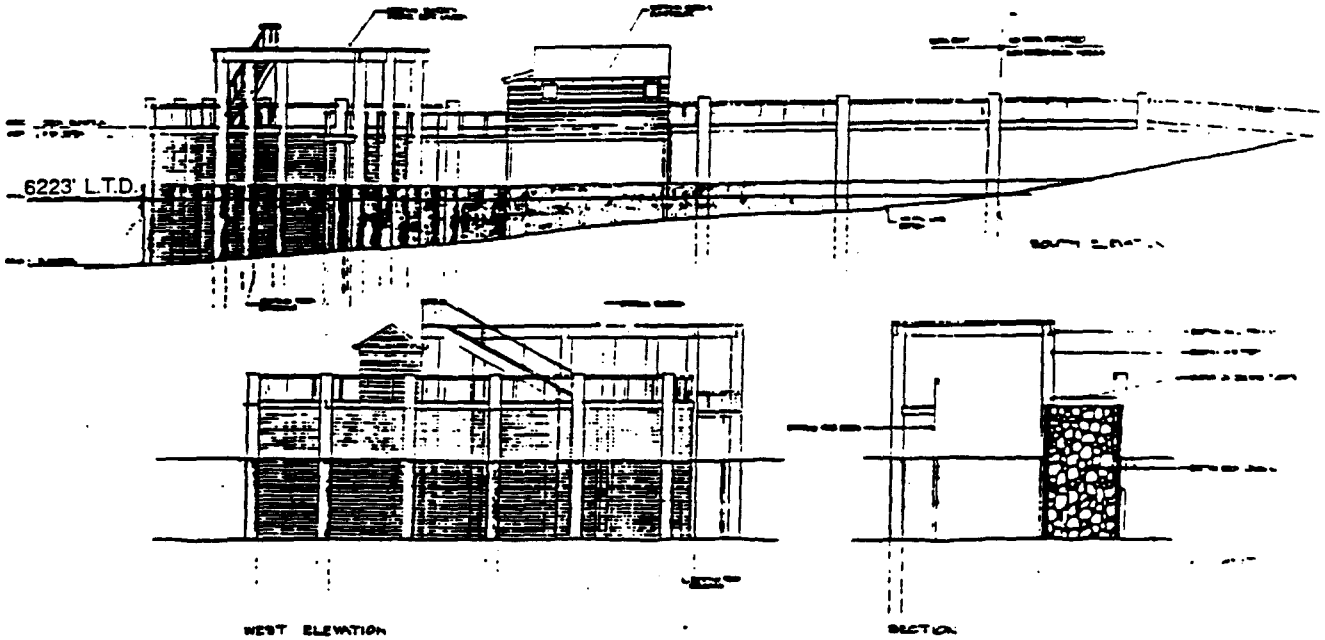
