TERMINATION OF RECREATIONAL PIER PERMIT  
AND ISSUANCE OF GENERAL LEASE - RECREATIONAL USE

OTHER PERTINENT INFORMATION:

On December 16, 1982, the Commission authorized the issuance of a Recreational Pier Permit to Jimmy Warren Genn and Mr. & Mrs. James Reading for an existing walkway and pier located in the Napa River, Solano County. Subsequently, the upland parcel was subdivided into two parcels, with the property line division intersecting the middle of the walkway and pier.

On September 30, 1991, the parcel improved with a single-family residence was sold by the Lessee. After acquiring the parcel, the new owner expressed no interest in using the pier and refused to be included as the joint applicant for this lease. Lacking cooperation from the new owner, Lessee proposed to relocate and reconstruct the walkway and pier solely on their property and State lands adjacent to their property.

Since the Lessee's upland property is currently vacant, the proposed walkway and pier relocation project will not qualify for rent-free status pursuant to Section 6503.5 of the P.R.C.

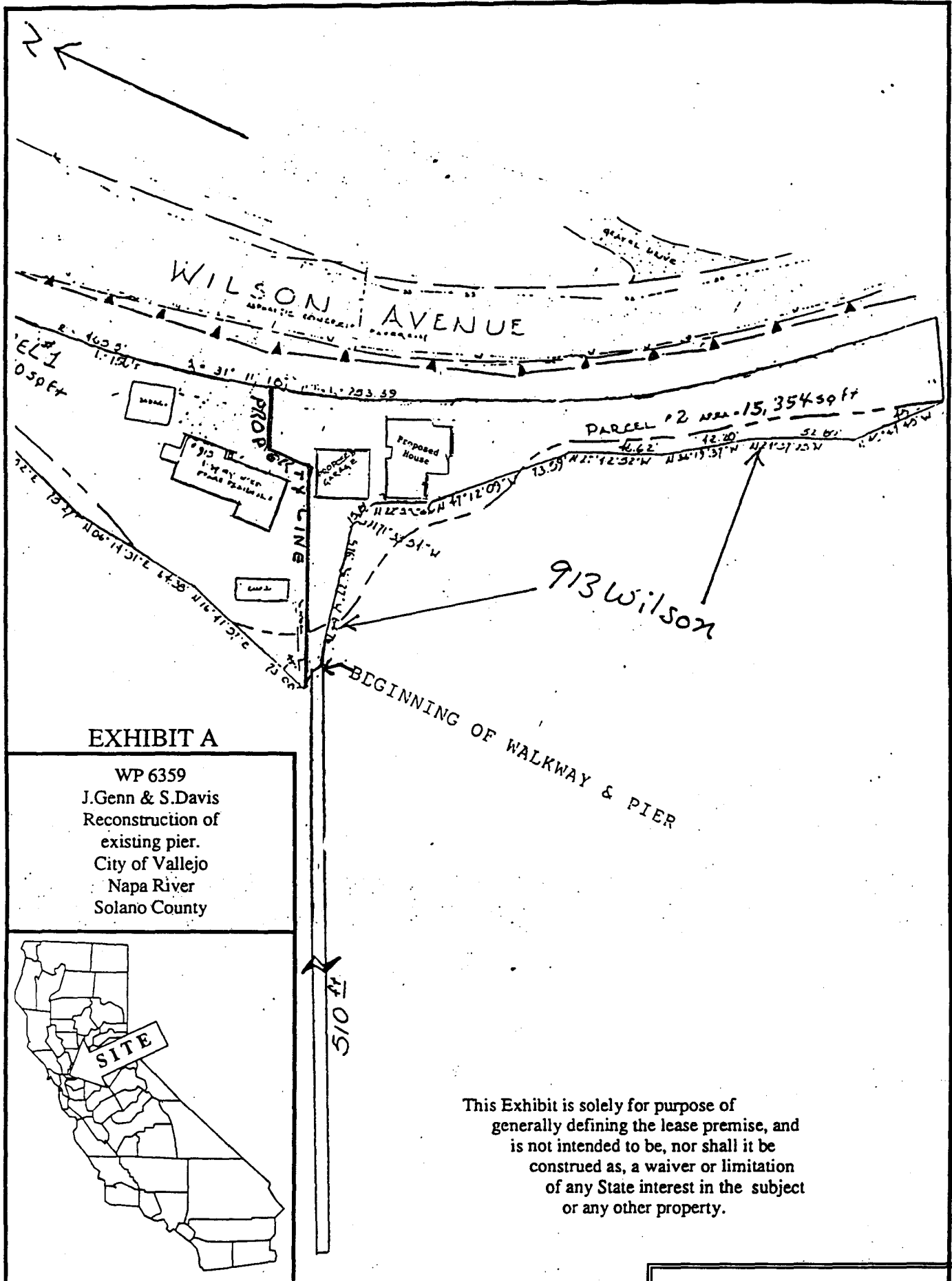

**AUTHORIZATION:**

AUTHORIZE TERMINATION OF A RECREATIONAL PIER PERMIT PRC 6359 AND ISSUANCE TO JIMMY WARREN GENN AND STEVEN LLOYD DAVIS OF A TEN YEAR GENERAL LEASE - RECREATIONAL USE, BEGINNING JUNE 1, 1995; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$443, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$500,000; FOR THE RELOCATION, RECONSTRUCTION AND MAINTENANCE OF AN EXISTING 4 FT.
