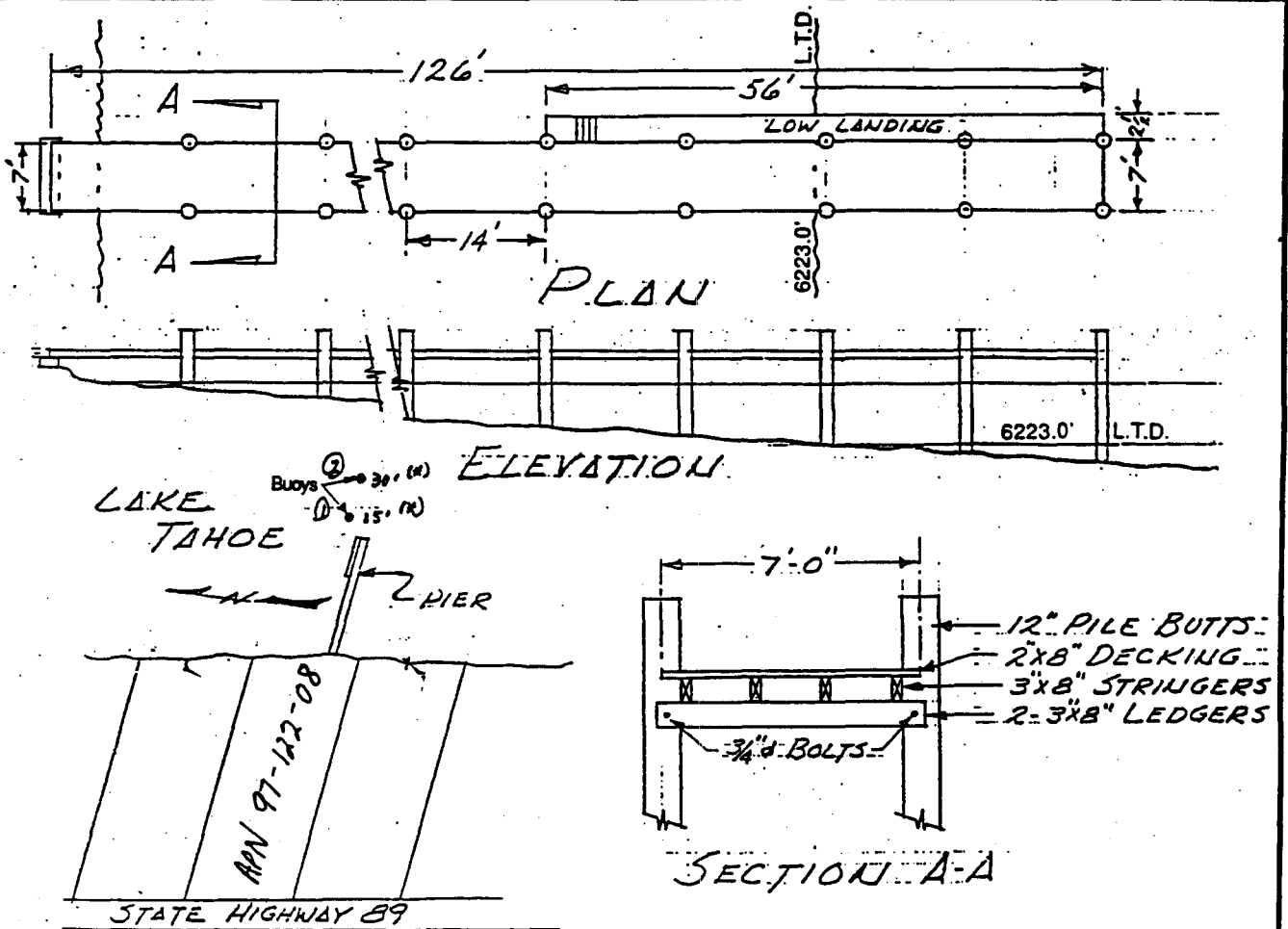

LOCATION MAP

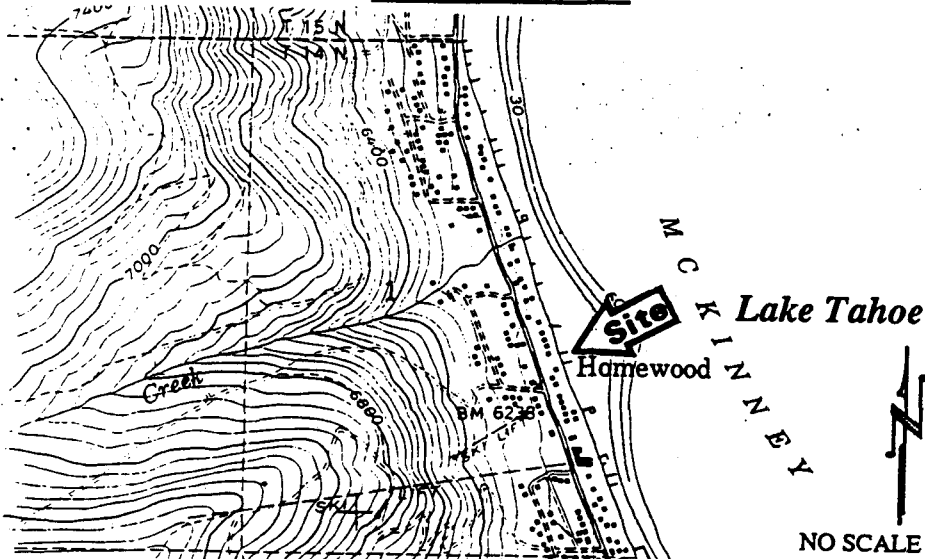


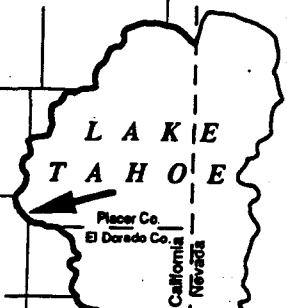
