AMENDMENT OF LEASE

LESSEE:

City of Santa Barbara
P. O. Box 1990
Santa Barbara, California 93102

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Pacific Ocean, east of Stearns Wharf and the Santa Barbara Harbor, City and County of Santa Barbara.

AUTHORIZED USE:

Construction and maintenance of a 48-inch sewer outfall pipeline, diffuser, rock ballast and anchors.

LEASE TERM:

49 years, beginning July 1, 1974.

CONSIDERATION:

The public health and safety; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

PROPOSED AMENDMENT:

Authorized Improvements:

Addition of one 42-inch diameter abandoned wastewater outfall pipeline.

Lease Description:

The land description contained in Section 3 of the lease is deleted and replaced with the attached description and identified as Exhibit C.

OTHER PERTINENT INFORMATION:

1. Lessee has a right to use the uplands adjoining the lease premises.

2. The 42-inch diameter wastewater outfall pipeline was designed and constructed by the Lessee in the 1920's. The wastewater pipeline has since been abandoned in place. Even though the wastewater pipeline is not currently being utilized, it is the Lessee's intent to leave the abandoned pipeline in place for possible future use. The 48" diameter wastewater pipeline is currently being actively used by the city.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a statutorily exempt project. The project is exempt because it involves an "ongoing project" as defined by the CEQA and the State CEQA Guidelines.

Authority: Public Resources Code section 21169 and Title 14, California Code of Regulations, section 15261.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

P. #54 on those certain Monumentation Maps filed in Book 2 of State Highway Monumentation Map Book at page 170; thence S 41° 57' 36" E, 8720.00 feet.
