GENERAL LEASE - RECREATIONAL USE

LESSEE:

The Bow Corporation, a California Corporation P.O. Box 1109
Red Bluff, California 96080

AREA, LAND TYPE, AND LOCATION:

0.04 acres, more or less, of sovereign lands in the Sacramento River, near the city of Red Bluff, Tehama County.

AUTHORIZED USE:

Continued use and maintenance of an existing 6 foot by 58 foot accommodation dock, a 6 foot by 8 foot accommodation dock, and a 6 foot by 14 foot walkway.

LEASE TERM:

Ten years, beginning April 6, 1998.

CONSIDERATION:

\$243 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Combined single limit coverage of no less than \$500,000.

Bond:

\$5,000

OTHER PERTINENT INFORMATION:

1. Applicant owns the uplands adjoining the lease premises.

3. This activity involves lands identified as possessing significantenvironmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

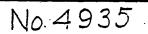

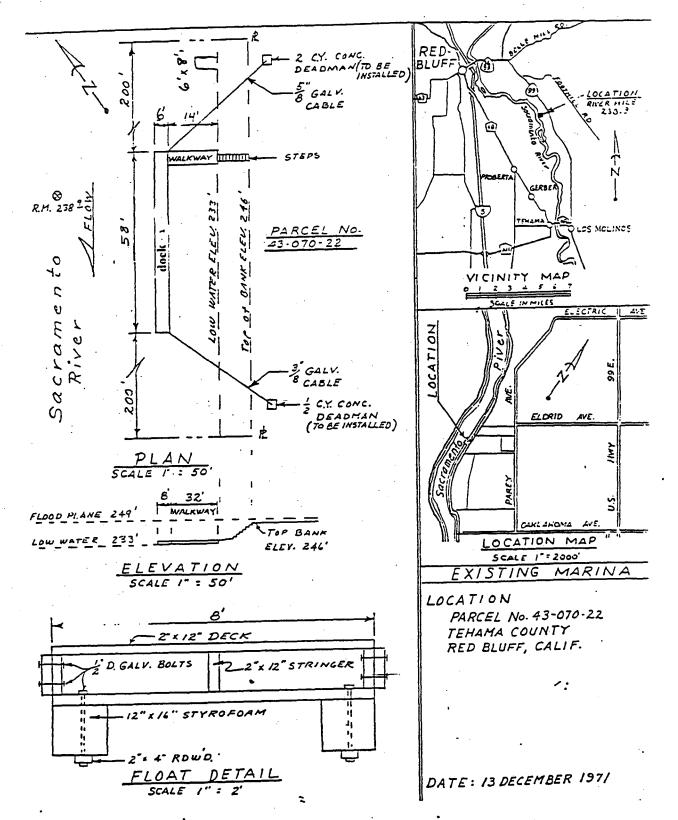
