### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Tahoe City, Placer County.

### AUTHORIZED USE:

Continued use of an existing recreational pier, two boat lifts, and two existing mooring buoys, as shown on the attached Exhibit A.

### LEASE TERM:

Ten years, beginning December 1, 1998.

### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

Insurance:
