GENERAL LEASE - RIGHT OF WAY

LESSEE:

Granite Construction Company 38000 Monroe Street Indio, California 92203

AREA, LAND TYPE, AND LOCATION:

.37 acres, more or less, of State lieu lands three miles south of Mojave, Kern County.

AUTHORIZED USE:

Maintenance of a water pipeline.

LEASE TERM:

Ten years, beginning September 1, 1999.

CONSIDERATION:

\$100 per year; with the State reserving the right to fix a different rent periodically during the lease term as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability Insurance: Combined single limit coverage of \$1,000,000.

Bond:

\$5,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant has a right to use the lands adjoining the lease premises.
- 2. Applicant is requesting a right of way lease in order to assume maintenance of an existing water pipeline previously covered under Lease No. PRC 7132.2. This lease, issued to Shell Oil Company, included the water pipeline, monitoring well, and a portion of a processing pond on

State lieu land, used in conjunction with its gold ore operations. Shell has ceased mining activity, is in the final phases of the closure process, and has sold its mineral lease and mining equipment to the Applicant. Shell has requested that its lease be amended to delete the water pipeline and a lease be issued to the Applicant for the water pipeline, which is needed as part of the Applicant's operation of crushing reclaimed rock to make aggregate. The source of the water is located on private property.

- 3. Pursuant to the preceding calendar item, staff is recommending that the Commission authorize the amendment of Lease No. PRC 7132.2.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
