RECREATIONAL PIER LEASE

APPLICANTS:

Mark Kaprielian and Jan A. Kaprielian Post Office Box 4640 Foster City, California 94404

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Georgiana Slough, near Isleton, Sacramento County.

AUTHORIZED USE:

Construction, use, and maintenance of a 60 foot by 6 foot retractable boat dock, an 8 foot by 20 foot retractable landing, and a retractable gangway.

LEASE TERM:

Ten years, beginning February 1, 2002.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

- Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.
- 2. Regarding the dock retraction mechanism, the design concept utilizes pin hinges and cable winches to enable the dock and gangway to collapse against the levee. A winch, attached to a turntable and mounted on a steel piling, is located

on the levee crown upstream of the concrete abutment where the gangway attaches. That winch is utilized to retract the dock and control its deployment back into the waterway. A second winch, installed in the access float, would be utilized to play out or retract as the dock is moved in and out. Additional upstream cable anchorage is anticipated to provide additional stability when the dock is fully extended.

- 3. A Mitigated Negative Declaration was prepared and adopted for this project by Sacramento County on June 11, 2001 (SCH #200082113). The California State Lands Commission's staff has reviewed such document.
- 4. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. 

Environmental Mitigation Measures

- D. In addition, pursuant to Section 5097.98 of the State Public Resources Code and Section 7050.5 of the State Health and Safety Code, in the event of the discovery of human remains, all work is to stop and the County Coroner shall be immediately notified if the remains are determined to be Native American, guidelines of the Native American Heritage Commission shall be adhered to in the treatment and disposition of the remains.
- E. Comply with the Mitigation Monitoring and Reporting Program (MMRP) for this project as follows:
 - 1. The proponent shall comply with the MMRP for this project, including the payment of 100% of the Department of Environmental Review and Assessment staff costs, and the costs of any technical consultant services incurred during implementation of the MMRP. The initial estimate of these costs is \$3,250.00. If the initial estimate exceeds the actual monitoring costs, the balance shall be refunded to the proponent, and if the actual monitoring costs exceed the initial estimate, the proponent shall be responsible to pay the additional amount.

SUMMARY

It shall be the responsibility of the project applicant to provide written notification to the Environmental Coordinator, in a timely manner, of the completion of each Mitigation Measure as identified on the following pages. The Department of Environmental Review and Assessment will verify, within ten (10) business days of notification that the project is in compliance. Any non-compliance will be reported to the project applicant, and it shall be the project applicant's responsibility to rectify the situation by bringing the project into compliance and re-notifying the Environmental Coordinator. Any indication that the project is proceeding without good-faith compliance could result in the imposition of administrative, civil and/or criminal penalties upon the project applicant in accordance with Chapter 20.02 of the Sacramento County Code.

It shall be the responsibility of the project applicant to reimburse the County for all expenses incurred in the implementation of the Mitigation Monitoring and Reporting Program, including any necessary enforcement actions. The initial estimate of County monitoring costs for this project is \$3,250.00, which must be paid to the Department of Environmental Review and Assessment. If actual County monitoring costs are less than the initial estimate, the difference will be refunded to the applicant; and if the actual County monitoring costs exceed the initial estimate, a supplemental bill will be submitted to the applicant.

Pursuant to Section 20.02.060 of the Sacramento County Code, upon the determination of the Environmental Coordinator that compliance with the terms of the approved Mitigation Monitoring and Reporting Program has been achieved, and that there has been full payment of all fees for the project, the Environmental Coordinator shall issue and the Clerk of the Board shall record a Program Completion Certificate for the project.





At that time, the Department of Environmental Review and Assessment will coordinate any necessary investigation of the find with appropriate specialists as needed. The project proponent shall be required to implement any mitigation deemed necessary for the protection of the cultural resources. In addition, pursuant to Section 5097.98 of the State Public Resources Code and Section 7050.5 of the State Health and Safety Code, in the event of the discovery of human remains, all work is to stop and the County Coroner shall be immediately notified if the remains are determined to be Native American, guidelines of the Native American Heritage Commission shall be adhered to in the treatment and disposition of the remains.

Implementation and Notification (Action by Project Applicant):

- 1. Include the above measure verbatim as a Construction Note on any/all Preliminary Grading Plans, Improvement Plans and Building/Development Plans which are submitted to the Department of County Engineering and/or the Planning Department for this project, as well as any/all revisions to those Plans which are subsequently submitted.
- 2. Comply fully with item #1 in the Standard Provisions section of this Mitigation Monitoring and Reporting Program.
- 3. If cultural resources are encountered, notify the Department of Environmental Review and Assessment immediately.
- 4. If human remains are encountered, notify the County Coroner and the Department of Environmental Review and Assessment immediately.
- 5. If no cultural resources are encountered, provide the Department of Environmental Review and Assessment with a signed statement to that effect.
