CONSIDER APPROVAL OF THE AWARD OF THE ROYALTY OIL SALES CONTRACT, OIL AND GAS LEASE NOS. PRC 91, PRC 163, PRC 425, PRC 426 AND E-392, HUNTINGTON BEACH OIL FIELD, ORANGE COUNTY

APPLICANT:

BACKGROUND:

At its meeting on November 26, 2001, the California State Lands Commission (Commission) authorized the sale of royalty crude oil from several Oil and Gas Leases in Orange County. Paramount Petroleum Corporation (Paramount) is presently purchasing the State's share of crude oil from these leases. Paramount is paying the State a bonus of \$0.432 per barrel above a base price defined as the highest price posted in the Huntington Beach Field for oil of like gravity and quality among the postings of ChevronTexaco, ExxonMobil Corporation, Union 76 and Equiva Trading Company, or any successors in interest to these companies. The State's share of production is approximately 1,025 B/D. The present royalty oil sales contact is for a term of twelve months. Royalty oil from these leases may be taken in kind or returned to the lessee on 90 days prior written notice.

A Notice Inviting Bids for a new Royalty Oil Sales Contract to run from June 1, 2002, until January 1, 2003, was published in the Orange County Register on November 26, 2001, and sent to all known interested parties. Bids were received and opened on December 11, 2001. Exhibit A, attached hereto, shows the results of the bidding.
