CONSIDER APPROVAL OF THE AWARD OF THE CRUDE OIL SALES CONTRACTS TO THE HIGHEST RESPONSIBLE BIDDERS, TRACT NO. 1, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

APPLICANT:

City of Long Beach Department of Oil Properties Attn.: Mr. Sigmund Jacoby 211 E. Ocean Blvd., #500 Long Beach, CA. 90802

BACKGROUND:

At its meeting on January 30, 2002, the California State Lands Commission (Commission) authorized the sale by the Field Contractor of 100 percent (100%) of the crude oil available for sell-off from Tract No. 1 of the Long Beach Unit, Wilmington Oil Field. This crude oil is 12½ percent (12½%) of the crude oil allocated to Tract No. 1, all of which comes from the Field Contractor's 80 percent (80%) share. The crude oil was offered for sale in two separate sales contracts. One contract is for seven percent (7%) of the oil allocated to Tract No. 1, which consists of approximately 2, 388 B/D. The second sales contract is for five and one-half (5-½%) of the crude oil allocated to Tract No. 1, which consists of approximately 1, 860 B/D. This crude oil is currently being sold in two contracts, one with Edgington Oil Company (Edgington) (7%) and the other with Valero Energy Company (Valero) (5 1/2%). Edgington is paying a bonus of \$0.8775 per barrel over the contract's base price, and Valero is paying a bonus of \$0.93 per barrel over the contract's base price.

A Notice Inviting Bids for the two new crude oil sales contracts, which are to run from March 1, 2003 to September 1, 2004, was published in the Long Beach Press-Telegram on April 2, 2002 and sent to all know interested parties. Bids were received and opened on May 2, 2002. Exhibit A attached hereto shows the results of the bidding.
