## LEASE TERM:

30 years, beginning October 14, 1988.

# **CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$726 per year, effective October 14, 2003.

#### OTHER PERTINENT INFORMATION:

 On September 14, 1988, the Commission authorized a General Lease – Right Of Way Easement to Pacific Gas and Electric Company for a term of 30 years. The easement is for an electrical power transmission facility across three parcels of State School Land comprising 6.72 acres located six to 24 miles west of Redding. This lease will expire on October 13, 2018.






# **SITE MAP**
