RECREATIONAL PIER LEASE

APPLICANTS:

Richard W. Tesene and Diane J. Tesene, as Trustees under the Tesene 1993 Revocable Intervivos Trust, dated July 15, 1993.

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Montezuma Slough, Grizzly Island, Solano County.

AUTHORIZED USE:

Continued use and maintenance of an existing walkway, boathouse, ramp, and floating boathouse.

LEASE TERM:

Ten years, beginning October 8, 2003.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

On September 9, 1993, the Commission approved a Recreational Pier Permit with Richard W. Tesene. That lease expired on October 7, 2003. Now Richard W. Tesene and Diane J. Tesene, as Trustees under the Tesene 1993 Revocable Intervivos Trust, dated July 15, 1993, are applying for a new Recreational Pier Lease. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.




