REQUEST AUTHORITY FOR THE EXECUTIVE OFFICER TO EXECUTE INTERAGENCY AGREEMENT WITH THE DEPARTMENT OF FISH AND GAME FOR STAFF COSTS RELATED TO THE BALLAST WATER MANAGEMENT PROGRAM

APPLICANT:

California State Lands Commission 100 Howe Avenue, Suite 100 – South Sacramento, CA 95825-8202

PROPOSAL:

The Executive Officer requests delegation of authority execute an Interagency Agreement with the Department of Fish and Game (DFG) in an amount of \$200,000 to provide for State Lands Commission staff cost pursuant to the Ballast Water Management Program.

BACKGROUND INFORMATION:

On September 24,2003, the Legislature passed AB 433 (Chapter 491/2003) enacting the Marine Invasive Species Act. This action effectively extended and modified Chapter 849/99, which established the initial program which was to sunset on December 31, 2003. The Commission and the DFG have worked closely in the implementation of this program. The parties have determined it would be in the best interests of the program to use a portion of the DFG appropriation to fund additional data collection activities by the Commission. The Department's budget appropriation from the Marine Invasive Species Control Fund has sufficient funding for this purpose and the fund is solvent. The Department of Finance has been advised of this transaction and has consented to the use of the funds in this manner.
