CONTINUATION OF RENT

LESSEES:

Greg Torlai, Glen Burgin and Robert Reynolds

AREA, LAND TYPE, AND LOCATION:

3,357 acres, more or less, of State School Lands located approximately three miles northeast of the town of Litchfield, Lassen County.

AUTHORIZED USE:

Livestock grazing.

LEASE TERM:

Ten years, beginning November 22, 1999.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$500 per year, effective November 22, 2005.

OTHER PERTINENT INFORMATION:

1. On June 27, 2000, the Commission authorized a General Lease – Grazing Use to Greg Torlai, Glen Burgin and Robert Reynolds for a term of ten years. The lease is for livestock grazing on State School Lands, totaling approximately 3,357 acres, located near the town of Litchfield. This lease will expire on November 21, 2009.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.

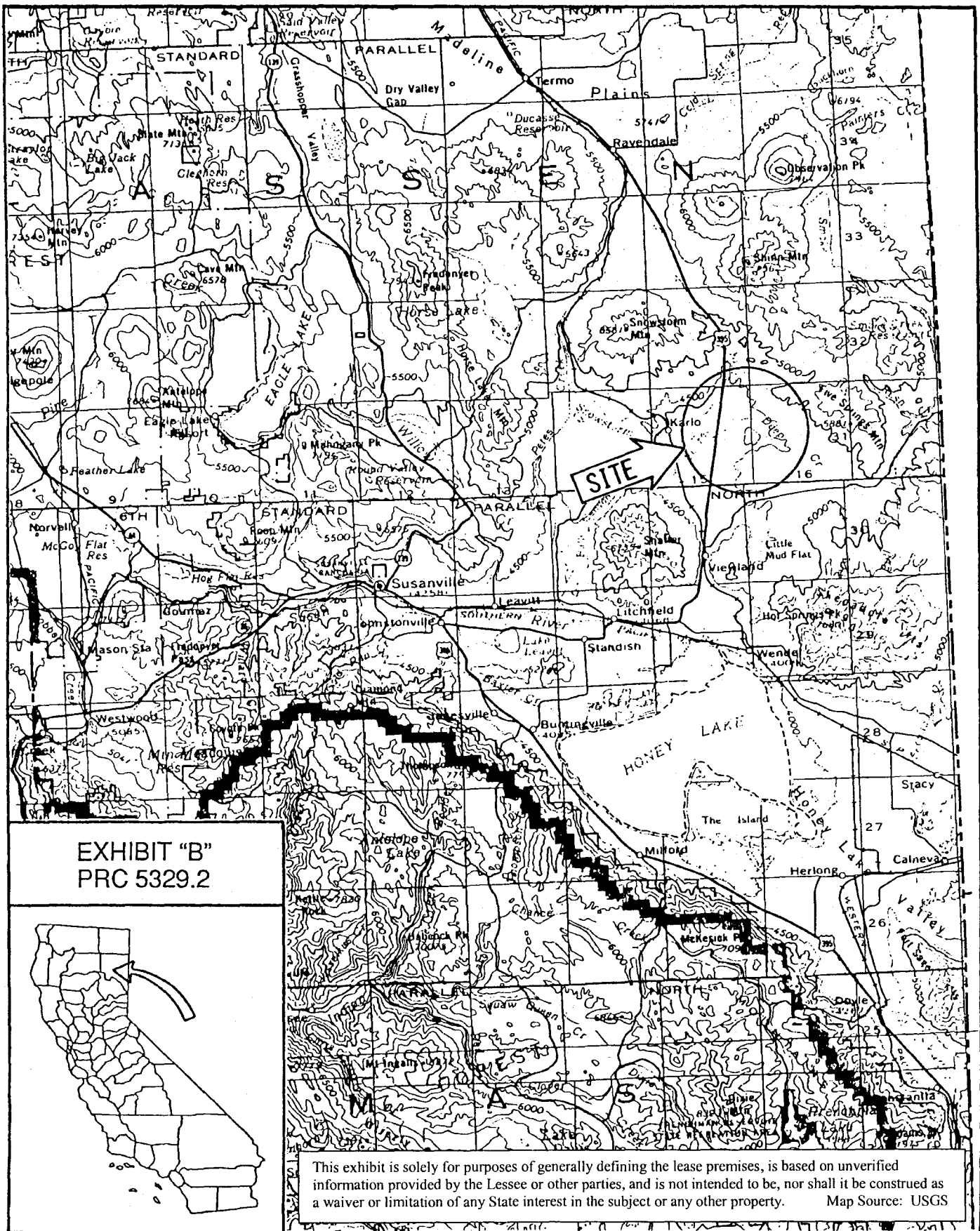
