CONSIDER APPLICATION FOR A GENERAL LEASE — PUBLIC AGENCY USE, OF APPROXIMATELY 24 ACRES OF PUBLIC TRUST LANDS SITUATED NEAR THE INTERSECTION OF JEFFERSON AND LINCOLN BOULEVARDS, LOS ANGELES COUNTY, TO THE CALIFORNIA DEPARTMENT OF FISH AND GAME

#### APPLICANT:

#### AREA, LAND TYPE, AND LOCATION:

24 acres, more or less, of public trust lands adjacent to the Ballona Wetlands, near the intersection of Jefferson and Lincoln Boulevards, Los Angeles County.

#### **AUTHORIZED USE:**

Management of the Expanded Wetlands Parcel and possible inclusion in the proposed Ballona Wetlands Ecological Reserve.

#### **LEASE TERM:**

49 years, beginning July 1, 2005.

#### **CONSIDERATION:**

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.


#### OTHER PERTINENT INFORMATION:

- 1. Applicant owns the land adjoining the lease premises.
- 2. The Commission acquired the 24 acres of public trust lands, located in the Ballona Wetlands, in February 2004. The Commission authorized the acquisition, known as the Expanded Wetlands Parcel, on December 9,

2003, (Minute Item 41). In addition, the deed to an adjacent 38-acre parcel, known as the Freshwater Marsh, was also recorded on the same date, as previously authorized on December 16, 1998 (Minute Item 115).

The conveyance of both parcels, totaling about 60 acres, to a public entity was required by the terms of an agreement between the developer of the area known as Playa Vista and a Trustee acting on behalf of the State Controller as beneficiary. The Freshwater Marsh parcel contains a marsh constructed as a requirement of certain Tract Maps approved by the city of Los Angeles for the Playa Vista development. The Commission took title to the Freshwater Marsh subject to numerous easements and covenants that require the property to be managed in perpetuity as a freshwater marsh.

- 4. The Wildlife Conservation Board, acting on behalf of the Department of Fish and Game (DFG), has acquired over 500 acres of the Ballona Wetlands. The California Coastal Conservancy (Conservancy), with the cooperation of the DFG and the Commission, has recently begun developing a plan for the Ballona Wetlands Restoration on DFG lands and the Commission's Expanded Wetlands Parcel. At the appropriate time in the planning process, the proposed restoration will undergo environmental review under the California Environmental Quality Act. The goals of the Conservancy plan are to:
  - Restore and enhance saltwater influenced wetland habitats to benefit endangered and threatened species, migratory shorebirds, waterfowl, seabirds, and coastal fish and aquatic species. Restoration of seasonal ponds, riparian and freshwater wetlands, and upland habitats will be considered where beneficial to another project goal or biological and habitat diversity.
  - Provide for wildlife-oriented public access and recreational opportunities compatible with the habitats, fish and wildlife conservation.
  - Identify and implement a cost-effective, ecologically beneficial, and sustainable (low maintenance) habitat restoration alternative.
- 5. DFG submitted a request to the Fish and Game Commission to designate its Ballona Wetlands property as the Ballona Wetlands Ecological

Reserve. The Fish and Game Commission is expected to make a final decision on the request in August. By leasing the Commission's Expanded Wetlands Parcel to the DFG, the property could be included in the proposed Ecological Reserve. This would allow for integrated management by the DFG with its larger property and ensure that the Expanded Wetlands Parcel receives full consideration in the wetlands restoration planning process.

The DFG has indicated its willingness to lease the Expanded Wetlands Parcel from the Commission and proposes that it be included in the Ecological Reserve. The DFG has also indicated that the Freshwater Marsh Parcel would not be appropriate for inclusion in its proposed Ecological Reserve.

Staff believes that the proposed lease to the DFG and designation of the Expanded Wetlands Parcel as part of the Ballona Wetlands Ecological Reserve is in the best interests of the State.

Should jurisdiction of the Ballona Wetlands change to another State agency, the proposed lease would be transferable upon the DFG's request and the Commission's approval.

6. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 7, Actions by Regulatory Agencies for Protection of Natural Resources; Title 2, California Code of Regulations, section 2905 (f)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations section 2905.

7. The Commission took ownership of the property in February 2004, as public trust lands.

This activity involves lands which were not identified in 1975 as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. However, the Commission has declared that all public trust lands are "significant" by nature of their public ownership.


