This lease is conditioned on the Assignees obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Draft Environmental Impact Statement (EIS) and approval of the ordinances based on the EIS.

### OTHER PERTINENT INFORMATION:

- 1. Assignees own the uplands adjoining the lease premises.
- 2. On December 8, 2005, the Commission authorized a General Lease Recreational Use with Alexander Court, L.L.C., A Ltd. Liability Co. That lease will expire on November 30, 2015. On November 30, 2005, Lessee transferred a two-thirds interest in the littorial property to Alexander Court, L.L.C., A Delaware Limited Liability Company, and a one-third interest in the littorial property to Robert J. Whalen and Kirsten J. Whalen, Trustees of The Robert J. Whalen and Kirsten J. Whalen Family Trust dated February 10, 1987, who are now applying for an assignment of General Lease Recreational Use No. PRC 4204.1, effective November 30, 2005.
- 3. 
