RECREATIONAL PIER LEASE

APPLICANT:

Peter J. Hogg

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Corte Madera Creek, near Kentfield, Marin County.

AUTHORIZED USE:

Use and maintenance of an existing uncovered floating boat dock, landing, ramp, and pilings as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning April 17, 2006.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Applicant owns the the uplands adjoining the lease premises and has applied for a lease. Applicant qualifies for a Recreational Pier Lease because he is a natural person who has improved the littoral land with, and uses the upland for, a single-famliy dwelling.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2; California Code of Regulations, section 2905 (c)(1).

CALENDAR ITEM NO. C15 (CONT'D)

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

3. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

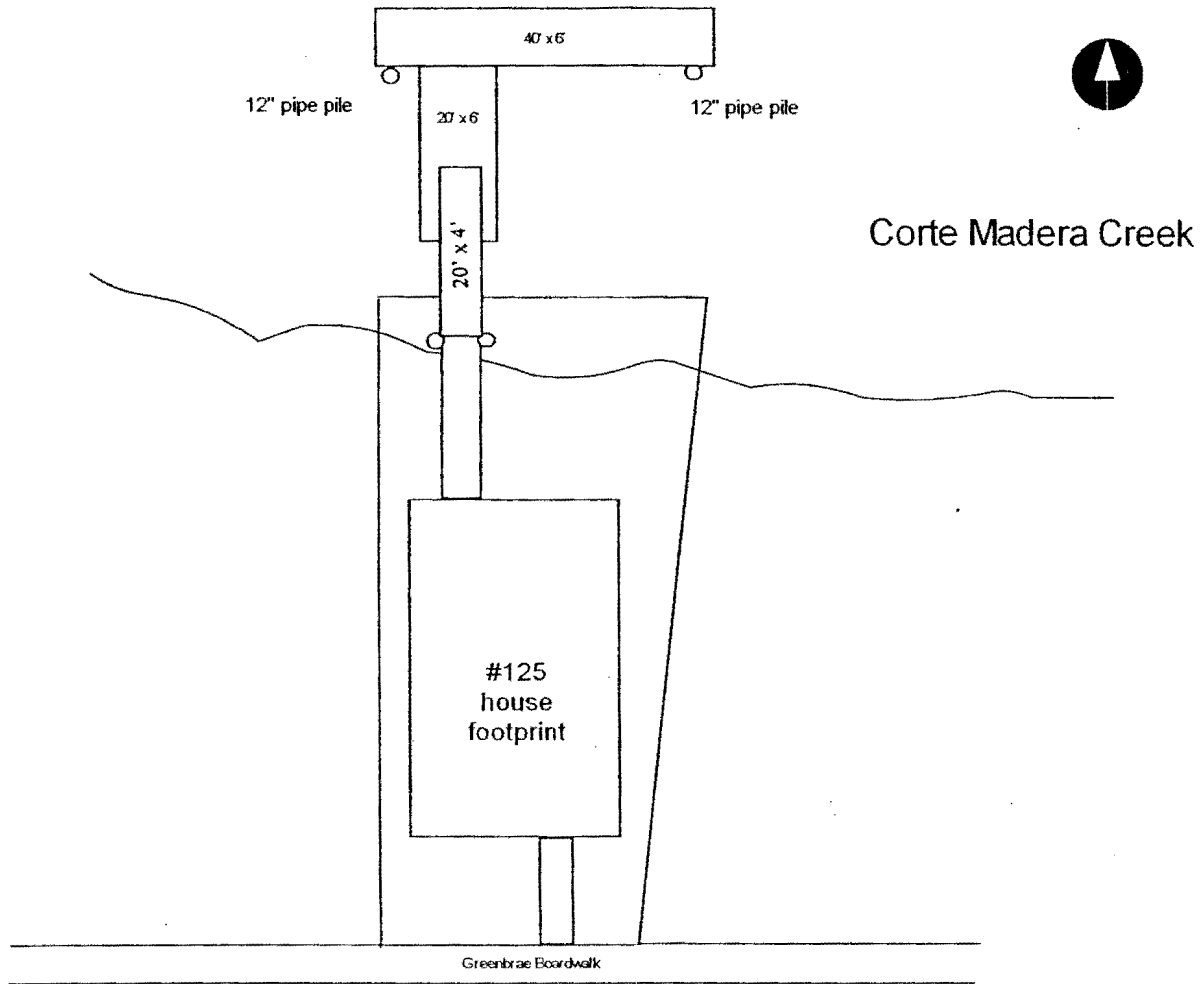

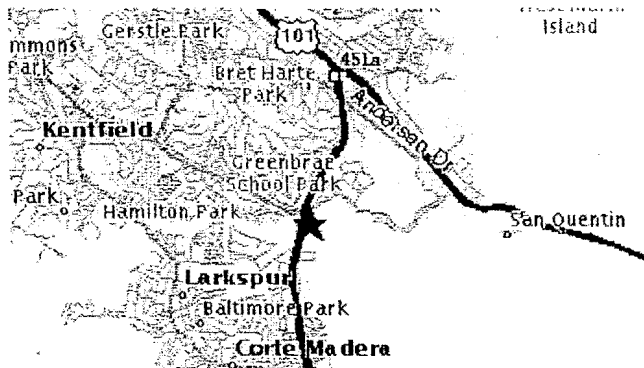
