Salvatore P. Scurti and Shirley A. Scurti, as Trustees of the Scurti Family Revocable Trust of February 3, 1997

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, Tahoe City, Placer County

#### **AUTHORIZED USE:**

Continued use and maintenance of one existing mooring buoy as shown on attached Exhibit A.

#### LEASE TERM:

Ten years, beginning August 8, 2006

#### **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000

#### OTHER PERTINENT INFORMATION:

- 1. Applicants own the uplands adjoining the lease premises.
- 2. On May 9,1996, the Commission authorized a Recreational Pier Lease with Salvatore and Shirley Scurti for an existing mooring buoy. That lease will expire on August 7, 2006. The property ownership has since been transferred to Salvatore P. Scurti and Shirley A. Scurti, as Trustees of the Scurti Family Revocable Trust of February 3, 1997. Applicants are now applying for a new Recreational Pier Lease. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land, and use the upland for, a single-family dwelling.






