GENERAL LEASE - PUBLIC AGENCY USE

APPLICANT:

City of Huntington Beach 2000 Main Street Huntington Beach, CA 92648

AREA, LAND TYPE, AND LOCATION:

0.030 acres, more or less, of sovereign lands adjacent to the Bolsa Chica Interpretive Center and across the street from Warner Avenue Fire Station No. 7, city of Huntington Beach, Orange County.

AUTHORIZED USE:

Upgrade, construct and maintain traffic signal poles, pull-boxes, conduit and loop detectors adjacent to the driveway entrance of the Bolsa Chica Interpretive Center.

LEASE TERM:

20 years, beginning June 26, 2006.

CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant has the right to use the uplands adjoining the lease premises.
- 2. On March 21, 2005, the Huntington Beach City Council (City) approved an amendment to the City's Capital Improvement Program by authorizing

bids to upgrade and construct the Warner Avenue Fire Station (Fire Station) Traffic Signal. The City has applied for a General Lease – Public Agency Use for that portion of the signal upgrade which will take place on sovereign lands adjacent to the Bolsa Chica Interpretive Center's (Center) parking lot, in the vicinity of the Bolsa Chica Wetlands in Huntington Beach and across the street from the Fire Station. This upgrade from a flashing signal to an actuated traffic signal will benefit local traffic control and visitors to the Center. The project is slated to begin in late June 2006, and be completed within 90 days of the project's start date.

- 3. On October 3, 2005, the city of Huntington Beach, acting as the lead agency under the provisions of the California Environmental Quality Act (CEQA) determined that construction and upgrading of the Warner Fire Station Traffic Signal, as described above, was categorically exempt from the CEQA pursuant to section 15302 under Class 2, Replacement or Reconstruction. Staff concurs with the city of Huntington Beach's determination.
- 4. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. However, the Commission has declared that all state school lands and submerged lands are "significant" by nature of their public ownership (as opposed to "environmentally significant"). Since such declaration of significance is not based upon the requirements and criteria of Public Resources Code sections 6370, et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by Title 2, California Code of Regulations, section 2954 is not applicable.




