GENERAL LEASE - PUBLIC AGENCY USE

APPLICANT:

Wetherbee Lake Reclamation District 2096

AREA, LAND TYPE, AND LOCATION:

0.27 acres, more or less, of tide and submerged lands in Walthall Slough, near Lathrop, San Joaquin County.

AUTHORIZED USE:

Continued use and maintenance of three existing speed control buoys to post speed limit and minimize boat wakes in the area.

LEASE TERM:

15 years, beginning August 1, 2006.

CONSIDERATION:

The public health and safety; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

OTHER PERTINENT INFORMATION:

1. Applicant is permittee of the uplands adjoining the lease premises.
2. On August 26, 1976, the Commission authorized a 25-year General Lease – Public Agency Use to Wetherbee Lake Reclamation District 2096. That lease subsequently expired. The Wetherbee Lake Reclamation District 2096 is now applying for a new lease.

The County of San Joaquin adopted a resolution on August 26, 1975, designating portions of Walthall slough as a slow area for boating.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the

staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

AUTHORIZATION:

AUTHORIZE ISSUANCE TO WETHERBEE LAKE RECLAMATION DISTRICT 2096 OF A GENERAL LEASE – PUBLIC AGENCY USE, BEGINNING AUGUST 1, 2006, FOR A TERM OF 15 YEARS, FOR THREE EXISTING SPEED CONTROL BUOYS AS SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF;

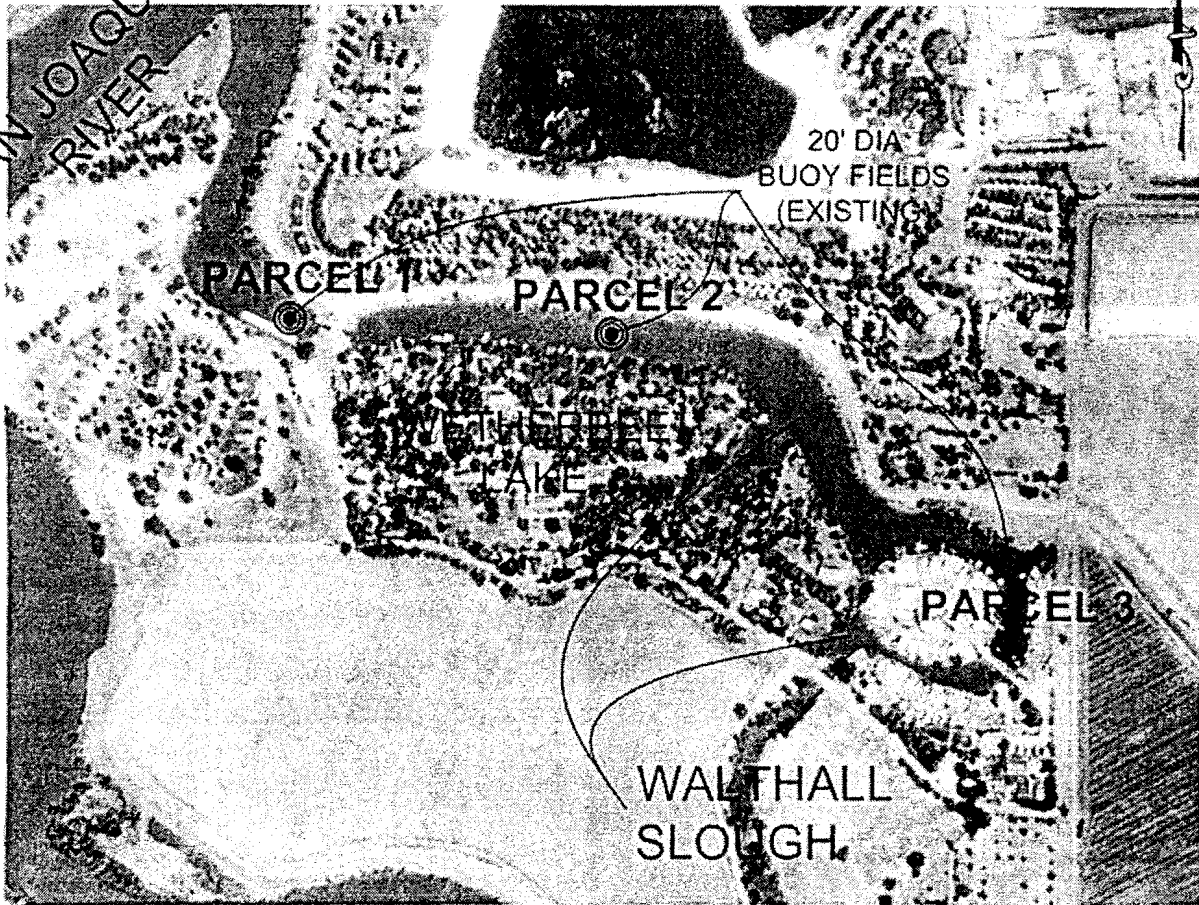

SITE

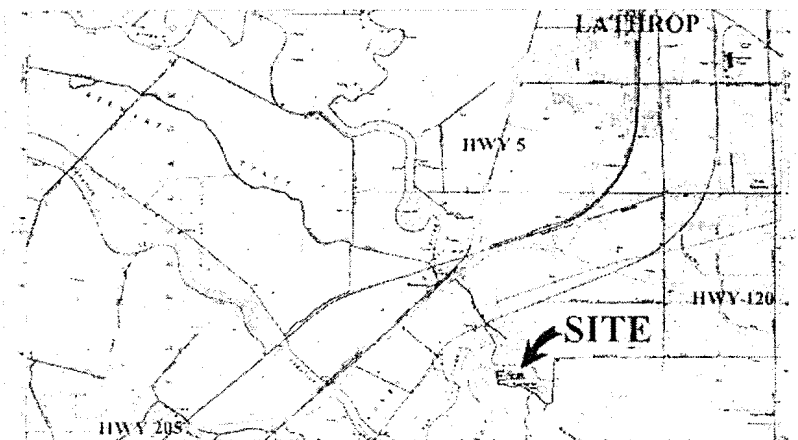
SAN JOAQUIN RIVER
