AMENDMENT OF GENERAL LEASE - PUBLIC AGENCY USE

LESSEE:

San Diego Unified Port District 3165 Pacific Highway San Diego, CA 92101

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in San Diego Bay, San Diego County.

AUTHORIZED USE:

Commercial and recreational navigation, including existing anchorage and mooring basin, buoys, boundary markers and navigational aids; breakwaters; access road; and existing industrial marine facilities.

LEASE TERM:

28 years, beginning July 1, 1997.

CONSIDERATION:

A minimum of \$10,000 per annum; or the total of the following, whichever is greater: (1) 10% of Lessee's gross income from Port operated moorings; and (2) 25% of Lessee's gross income from revenues generated by subleases on the lease premises.

PROPOSED AMENDMENT:

Authorize the installation of up to six mooring buoys in the northwesterly portion of the A-8 Anchorage area for use by Harbor Police and General Services Staff. All other terms and conditions of the lease shall remain in effect without amendment.

OTHER PERTINENT INFORMATION:

1. Lessee has a right to use the uplands adjoining the lease premises.

- 2. On August 26, 1997, the Commission authorized issuance to the San Diego Unified Port District (Port) of Lease No. PRC 7987.1, a General Lease Public Agency Use, beginning July 1, 1997, for a term of 28 years, for consolidation of eight existing leases into one Master Lease. The Lease was subsequently amended on January 30, 2002, to authorize the installation of a mooring dolphin and a portion of a catwalk associated with the extension of a wharf at the National City Marine Terminal. On June 18, 2002, the Commission approved a 20-year sublease between the Port and the San Diego Mooring Company for the operation and maintenance of four mooring buoy anchorage areas including both State lands leased by the Commission to the Port, as well as trust lands held by the Port pursuant to a legislative grant.
- 3. The Port is now proposing to install up to six mooring buoys/floats in the northwesterly portion of the A-8 Anchorage, a designated 80-acre anchorage area, offshore of the National City Marine Terminal. The mooring buoys will allow Port personnel to provide law enforcement services as well as property, health and public safety responses to emergency events in the A-8 Anchorage area. The buoys will provide locations to temporarily secure vessels while allowing law enforcement personnel to remain on the scene to address other emergencies. Currently, there are approximately 120 vessels anchored at the A-8 Anchorage area. The Port requires Permit renewal every six months for each vessel. Only non-commercial, seaworthy vessels less than 65 feet in length are permitted to anchor in the A-8 Anchorage area.
- 4. On December 6, 2005, the Board of Port Commissioners directed Port staff to commence a public outreach in order to obtain input to resolve issues of public safety, environmental impacts, navigational hazards and financial costs associated with maintaining the A-8 Anchorage area.
 - Several public meetings were held and Port staff continues to conduct further analysis in regards to long-term plans to address the above issues. Once the Port's analysis is complete, Commission staff will be contacted before any changes are implemented by the Port regarding the operation of the A-8 Anchorage area.
- 5. On April 28, 2006, the San Diego Unified Port District, acting as the lead agency under the provisions of the California Environmental Quality Act (CEQA), determined that the installation of six mooring buoys for use during emergency situations, as described above, were statutorily exempt

from the CEQA pursuant to section 15269, Emergency Projects, and categorically exempt from the CEQA pursuant to section 15303 under Class 3, New Construction of Small Structures and section 15311 under Class 11, Accessory Structures. Staff concurs with the San Diego Unified Port District's determination.

6. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process; it is the staff's opinion that the project, as proposed, is consistent with its use classification.


