SPECIFIC LEASE PROVISIONS:

Liability Insurance with coverage of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

- 1. Applicant has a right to use the uplands adjoining the lease premises.
- 2. On September 19, 2000, the California State Lands Commission (CSLC) approved the issuance of a 20-year General Lease Right of Way Use to Lodi Gas Storage, LLC, for the installation of a directionally bored single 24-inch diameter high-pressure gas pipeline under the Mokelumne, North and South Mokelumne Rivers, and Georgiana, Three Mile, Jackson, and Tomato Sloughs, near the city of Lodi, Sacramento and San Joaquin counties.
- 3. Lodi Gas Storage obtained an indebtedness in the amount of \$50,000,000 for improvements that were acquired, constructed, repaired or reconstructed by Lodi Gas Storage. On February 5, 2001, the Commission approved an "Agreement and Consent to Encumbrancing of Lease" to Lease No. PRC 8207.1. The Deed of Trust, Security Agreement, Assignment of Revenues and Contracts and Fixture Filing were executed by Lodi Gas Storage for the benefit of Newcourt Capital USA, Inc., as Beneficiary.
- 4. A Corporation Assignment of Deed of Trust from Newcourt Capital USA, Inc., to WHP Acquisition Company, LLC, was recorded on April 24, 2001, and the First Amended and Restated Deed of Trust, Security Agreement, Assignment of Revenues and Contracts and Fixture Filing executed by Lodi Gas Storage for the benefit of WHP Acquisition Company, LLC, was recorded on August 24, 2001. Subsequently a Corporation Assignment of Deed of Trust from WHP Acquisition Company, LLC to Lodi Finance, LLC was recorded on November 26, 2003. These assignments were not formally approved by the CSLC.

- 5. Lodi Gas Storage intends to enter into a new financing arrangement with certain Secured Party Lenders and Collateral Agent in order to refinance the loans for approximately \$145,000,000 for the expansion of the Lodi Gas Storage facility. Lodi Gas Storage intends to partially secure the loan by the Commission's lease.
- 6. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by the CEQA and the State CEQA Guidelines.


