**APPROVAL OF AN ASSIGNMENT OF LEASE  
AND AMENDMENT OF LEASE AS ASSIGNED**

**LESSEE/ASSIGNOR:**

Bolero Lane LLC  
c/o Nazir Antoun

**ASSIGNEE:**

Nazir S. Antoun, Trustee of the The Nazir and Mary Antoun Trust u/t/d  
June 13, 1985

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Huntington Harbour, near Huntington Beach, Orange County.

**AUTHORIZED USE:**

The continued use and maintenance of an existing boat dock, access ramp and  
cantilevered deck extending no more than five feet waterward of the existing  
bulkhead.

**LEASE TERM:**

Ten years, beginning April 25, 2003.

**CONSIDERATION:**

As to the boat dock, annual rent in the amount of \$256, with the State reserving  
the right to fix a different rent periodically during the lease term, as provided in  
the lease; as to the cantilevered deck, annual rent in the amount of \$1,013, with  
the State reserving the right to fix a different rent periodically during the lease  
term, as provided in the lease.

**PROPOSED AMENDMENT:**

Terminate the annual rental of \$256 for the existing boat dock, effective on the  
lease anniversary date of April 25, 2006. All other provisions of the lease shall  
remain in effect without amendment.

**OTHER PERTINENT INFORMATION:**

1. Assignee owns the uplands adjoining the lease premises.
2. On February 17, 2005, the Commission approved issuance of a General Lease - Recreational Use for a ten-year term, beginning April 25, 2003, to the Bolero Lane LLC (Lessee/Assignor) for an existing boat dock and access ramp, and for the construction and maintenance of a new cantilevered deck. On February 9, 2006, the Commission approved an amendment to the lease allowing for the removal and replacement of the existing boat dock with a larger dock. At that time, the dock was subject to annual rent due to the upland property being held as an asset of an LLC. The LLC, as a non-natural person, did not qualify for rent-free status for the boat dock under PRC section 6503.5. On February 20, 2006, the Lessee/Assignor transferred title to the upland property to Nazir S. Antoun, Trustee (Assignee). The Lessee/Assignor is now applying to the Commission for an assignment of Lease PRC 3568.1 to the Assignee as of February 20, 2006, and for an amendment to the lease to terminate the annual rental as to the boat dock effective as of April 25, 2006. The boat dock and ramp will qualify for rent-free status under PRC section 6503.5 as the upland owner is a Trust consisting of natural persons.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.

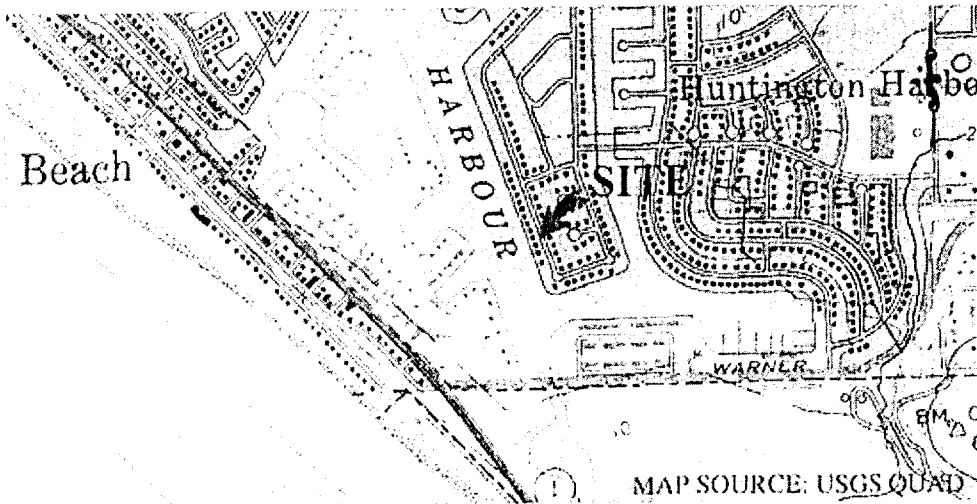

**LAND DESCRIPTION**

A parcel of submerged land in Huntington Harbour in the City of Huntington Beach, Orange County, California, described as follows:

Beginning at the most southerly corner of Lot 39, as said lot is shown and so designated on that certain map of Tract No. 5264 filed in Book 185, Pages 27 through 34 of Miscellaneous Maps, Official Records of said County; thence along the southwesterly extension of the southeasterly line of said lot 60.00 feet, more or less, to the pierhead line; thence northwesterly along said pierhead line to the southwesterly extension of the northwesterly line of said lot; thence along said extension 60.00 feet, more or less, to the most westerly corner of said lot; thence along the southwesterly line of said lot to the point of beginning.
