#### **REVISION OF RENT**

#### LESSEE:

Lake Point Beach Resort, LLC, A Nevada Limited Liability Company P.O. Box 157
Crystal Bay, NV 89402

#### AREA, LAND TYPE, AND LOCATION:

0.083 acres, more or less, of sovereign lands in Lake Tahoe, adjacent to 7650 North Lake Boulevard, near Kings Beach, Placer County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier, boat lift and two mooring buoys as shown on the attached Exhibit A.

#### LEASE TERM:

Ten years, beginning November 1, 2002.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$423 per year to \$1,563 per year, effective November 1, 2008.

#### OTHER PERTINENT INFORMATION:

On December 16, 2002, the Commission authorized a General Lease - Recreational Use with Lake Point Beach Resort, LLC, A Nevada Limited Liability Company, for the reconstruction, modification and extension of an existing pier, installation of a boat lift and retention of two existing mooring buoys. The Lessee is a limited liability company and is the littoral owner of the upland property. As the Lessee is not a natural person, it does not qualify for rent-free status, pursuant to Public Resources Code section 6503.5.




