## CONSIDER ACCEPTANCE OF THE FULL QUITCLAIM DEED OF OIL AND GAS LEASE NO. PRC 3503.1 (A PARCEL OF SUBMERGED LANDS IN THE SANTA BARBARA CHANNEL LYING SOUTH OF EL CAPITAN BEACH STATE PARK), SANTA BARBARA COUNTY

#### AREA, LAND TYPE, AND LOCATION:

Oil and Gas Lease No. PRC 3503.1 contains approximately 1,660 acres of submerged land in the Santa Barbara Channel in the vicinity of El Capitan Beach State Park, Santa Barbara County.

#### **BACKGROUND:**

On June 28, 1966, the California State Lands Commission (Commission) awarded Oil and Gas Lease No. PRC 3503.1 to Union Oil Company of California (Unocal) for the cash bonus of \$1,320,760.00. In 2005, Unocal was acquired by the parent of Chevron U.S.A. Inc. (Chevron). In 1967, one exploratory well was drilled on Lease No. PRC 3503.1. This well found no hydrocarbons and was abandoned to State standards and the site cleared.

On April 14, 2008, staff received a quitclaim deed for Lease No. PRC 3503.1 from Chevron. Public Resources Code section 6804.1 and Lease Paragraph 5 permit the lessee to make and file at any time a written quitclaim of all rights under the lease. The quitclaim will be effective when it is filed with the State subject to the continued obligation of the lessee and its surety to pay all accrued rentals and royalties and to abandon all wells drilled on the leased lands.



That certain tract of tide and submerged lands, situate in the county of Santa Barbara, State of California, described as follows:

BEGINNING AT THE INTERSECTION OF THE SEAWARD PROLONGATION OF THE WESTERLY BOUNDARY OF STATE OIL AND GAS LEASE P.R.C. 208 WITH A LINE PARALLEL TO THE ORDINARY HIGH WATER MARK OF THE SANTA BARBARA CHANNEL AND SEAWARD THEREFROM 3 NAUTICAL MILES; THENCE SOUTHERLY ALONG SAID SEAWARD PROLONGATION TO THE INTERSECTION WITH AN ENVELOPE LINE EVERY POINT OF WHICH IS AT A DISTANCE OF 3 GEOGRAPHICAL MILES FROM THE NEAREST POINT ON THE LINE OF ORDINARY LOW WATER OF THE SANTA BARBARA CHANNEL, OR AT A DISTANCE OF 3 GEOGRAPHICAL MILES FROM THE PRESENTLY EXISTING OUTERMOST PERMANENT HARBOR WORKS IF ANY WITHIN OR IN THE VICINITY OF THE LEASEHOLD AREA, WHICHEVER SHALL BE FURTHER SEAWARD; THENCE NORTHWESTERLY ALONG SAID ENVELOPE LINE TO THE INTERSECTION WITH A NORTH-SOUTH CALIFORNIA ZONE 5 GRID LINE HAVING AN 'X' COORDINATE OF 1,392,440 (SAID GRID LINE IS THE SOUTHERLY EXTENSION OF THE WESTERLY BOUNDARY OF P.R.C. 2205); THENCE NORTH ALONG SAID GRID LINE TO THE INTERSECTION WITH A LINE PARALLEL TO THE ORDINARY HIGH WATER MARK OF THE SANTA BARBARA CHANNEL AND SEAWARD THEREFROM 3 STATUTE MILES (SAID LINE BEING THE SOUTHERLY BOUNDARY LINE OF STATE OIL AND GAS LEASE P.R.C. 2205); THENCE SOUTHEASTERLY ALONG THE SOUTHERLY BOUNDARY LINE OF SAID LEASE TO THE INTERSECTION WITH A NORTH-SOUTH CALIFORNIA ZONE 5 GRID LINE HAVING AN 'X' COORDINATE OF 1,403,000; SAID GRID LINE BEING THE WESTERLY BOUNDARY OF P.R.C. 3004; THENCE SOUTH ALONG SAID NORTH-SOUTH GRID LINE TO THE INTERSECTION WITH A LINE PARALLEL TO THE ORDINARY HIGH WATER MARK OF THE SANTA BARBARA CHANNEL AND SEAWARD THEREFROM 3 NAUTICAL MILES (SAID LINE BEING THE SOUTHERLY BOUNDARY LINE OF THE STATE OIL AND GAS LEASE P.R.C. 3004); THENCE SOUTHEASTERLY ALONG THE SOUTHERLY BOUNDARY LINE OF SAID LEASE TO THE POINT OF BEGINNING; CONTAINING 1,660 ACRES MORE OR LESS.


