#### LESSEE:

AT&T Corporation 3001 Cobb Parkway, NW-Room 162 Atlanta, GA 30309

## AREA, LAND TYPE, AND LOCATION:

9.80 acres, more or less, of State school land located in five parcels all lying west of the Salton Sea, which include portions of Section 4, T11S, R10E, SMB, Section 10, T11S, R10E, SBM, and Sections 28, 30, 34, T10S, R9E, SMB, Imperial County.

#### **AUTHORIZED USE:**

Operation, use, and maintenance of a 0.5 inch diameter underground fiber optic cable.

#### LEASE TERM:

30 years, beginning August 1, 1990.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$599 per year, effective August 1, 2008.

#### OTHER PERTINENT INFORMATION:

On August 22, 1990, the Commission authorized a General Lease - Right of Way Use with American Telephone and Telegraph Company. That lease will expire on July 31, 2020. On February 2, 2006, the Commission authorized the assignment of Lease No. PRC 7428.2 from American Telephone and Telegraph Company to AT&T Corp., a Wholly-Owned Subsidiary of SBC Communications, Inc.
