# **GENERAL LEASE - RECREATIONAL AND PROTECTIVE STRUCTURE USE**

# APPLICANT:

John H. White, Trustee of the JHW Trust, dated May 16, 2000

# AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Sacramento River, adjacent to 4435 Garden Highway, city of Sacramento, Sacramento County.

# **AUTHORIZED USE:**

Continued use and maintenance of an existing uncovered floating boat dock, ramp, and bank protection as shown on Exhibit A.

# LEASE TERM:

Ten years, beginning June 1, 2008.

### CONSIDERATION:

Uncovered Floating Boat Dock and Ramp: No monetary consideration pursuant to Public Resources Code section 6503.5.

Bank Protection: The public use and benefit, with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

# SPECIFIC LEASE PROVISIONS:

Liability insurance with combined coverage of no less than \$500,000.

# OTHER PERTINENT INFORMATION:

- 1. Applicant owns the uplands adjoining the lease premises.
- On June 19, 1998, the Commission authorized a General Lease -Recreational and Protective Structure Use with John H. White. That lease expired on May 31, 2008. The upland property has since been deeded to John H. White, Trustee of the JHW Trust, dated May 16, 2000. The

Applicant is now applying for a new General Lease – Recreational and Protective Structure Use.

- 3. The Applicant qualifies for the rent free use of the uncovered floating boat dock and ramp because the Applicant is a natural person who owns the littoral land that is improved with a single-family dwelling pursuant to Public Resouces Code Section 6503.5.
- 4. The bank protection will mutually benefit both the public and the Applicant. The bank of the Sacramento River will have the additional protection from wave action provided at no cost to the public.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

6. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


