REVISION OF RENT

LESSEES:

Frederick G. Rose and Barbara Ryan Rose, Trustees of the Frederick G. Rose and Barbara Ryan Rose Revocable Living Trust, dated June 16/97

AREA. LAND TYPE. AND LOCATION:

Sovereign lands in Donner Lake, adjacent to 14578 South Shore Drive, near Truckee, Nevada County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier and boat house with a sundeck.

LEASE TERM:

Ten years, beginning August 4, 2003.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$86 per year to \$314 per year, effective August 4, 2008.

OTHER PERTINENT INFORMATION:

On December 9, 2004, the Commission authorized a General Lease – Recreational Use with Frederick G. Rose and Barbara Ryan Rose, Trustees of the Frederick G. Rose and Barbara Ryan Rose Revocable Living Trust, dated June 16/97, for the continued use and maintenance of an existing pier, and boathouse with a sundeck. The Lessees are natural persons who have improved the littoral land with and use the upland for a single family dwelling. However, sundeck does not qualify for rent-free status because it is not used for the docking or mooring of boats.




