RECREATIONAL PIER LEASE

APPLICANTS:

C. Don Huff, Jr. and Mary K. Huff, Trustees of the C. Don Huff, Jr. and Mary K. Huff Family Trust Dated November 10, 2003

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, adjacent to 4150 Ferguson Avenue, near Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier, boat house with a pitched roof, and two mooring buoys and the retention of an existing boat hoist as shown on Exhibit A.

LEASE TERM:

Ten years, beginning February 22, 2009.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$500,000.

Other:

The lease contains a provision that requires the Applicants to obtain authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of the Lake Tahoe Shorezone Amendments-Final Environmental Impact Statement (FEIS) and approval of the ordinances based on the FEIS.

OTHER PERTINENT INFORMATION:

1. Applicants own the land adjoining the lease premises.

- 2. On April 13, 1999, the Commission authorized a Recreational Pier Lease with C. Don Huff, Jr. and Mary K. Huff. That lease expired on February 21, 2009. The upland property has now been transferred to the C. Don Huff, Jr. and Mary K. Huff, Trustees of the C. Don Huff, Jr. and Mary K. Huff, Trustees of the C. Don Huff, Jr. and Mary K. Huff Family Trust Dated November 10, 2003. Applicants are now applying for a new Recreational Pier Lease. The boat hoist has not been previously authorized by the Commission, but has been installed on the pier many years.
- 3. Applicants qualify for a Recreational Pier Lease because they are natural persons who own the littoral land that is improved with a single-family dwelling.
- 4. Pier, Boat House, and Two Mooring Buoys: Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

Retention of Boat Hoist: Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 14, California Code of Regulations, section 15303.

Authority: California Code section 21084 and Title 14, California Code of Regulations, section 15300.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
