AREA, LAND TYPE AND LOCATION:

Negotiated subsurface (no surface use) State Oil and Gas Lease No. PRC 8676.1 (Lease PRC 8676.1) contains a parcel of tide and submerged land in the bed of the Sacramento River situated in Sacramento County, California. The parcel contains approximately 30.24 acres, and is located within the California Division of Oil, Gas and Geothermal Resources' (DOGGR) District 6, River Island Gas Field.

BACKGROUND:

Lease PRC 8676.1 was issued on April 17, 2006, to Towne Exploration Company (Towne) for a term of three (3) years. At its meeting on May 10, 2007, the California State Lands Commission (Commission) approved the assignment of an undivided forty percent (40%) interest of Lease PRC 8676.1 to Capitol Oil Company (Capitol) effective June 1, 2007.

On March 21, 2006, Towne applied to the DOGGR for a permit to drill well "North Isleton" 24-1 in Sacramento County near Lease PRC 8676.1. However, this well was never drilled and the permit was canceled on April 9, 2008. As a result,



<u>Towne Exploration Company, a California limited partnership</u> (Assignor) assigned forty percent of its undivided right, title and interest under State Oil and Gas Lease No. PRC 8676.1 to <u>Capitol Oil Corporation, a California</u> <u>corporation</u> (Assignee). At its meeting on May 10, 2007, the State Lands Commission approved said assignment effective June 1, 2007. It was recorded in the Official Records of Sacramento County, in Book 20080826, at Page 1055, on August 26, 2008.
