**REQUEST AUTHORITY FOR THE EXECUTIVE OFFICER TO
EXECUTE AGREEMENTS FOR BUDGET FISCAL YEAR 2010-2011**

PROPOSED ACTIVITY

The Executive Officer requests authority to execute Agreements for Budget Fiscal Year 2010-2011. The following contracts require renewal:

1. Department of Justice \$100,000 Contract No. C2010-01

Interagency Agreement with the Department of Justice to provide the Commission legal consultative and investigative services to protect the State's interest within Long Beach tidelands under Chapter 29, Statutes of 1956 1st E.S., Chapter 138 Statutes of 1964 1st E.S., and the Alamitos Bay litigation.

2. Office of Technology Services \$150,000 Contract No. C2010-02

Interagency Agreement with Office of Technology Services to provide the Commission telecommunications, Internet access, local area network and system development services, equipment, software and support.

3. Board of Equalization \$434,000 Contract No. C2010-03

Interagency Agreement with the Board of Equalization (BOE) to provide the staff services for the collection of fees specified in the Marine Invasive Species Act, Chapter 491, Statutes of 2003. The Act specifies certain fee collection duties be performed by the BOE. The funding for these activities has been placed in the Commission's budget by the Department of Finance. An Interagency Agreement will be required between the agencies for this purpose.

4. County Assessor's Records \$100,000 est. Contract No. C2010-04

Solicit for a Contractor that will provide on-line access through an Internet connection to a real property search database of current county tax assessor's plat maps and ownership records for all 58 counties of California. Agreement shall be for three fiscal years subject each year to the availability of funds.

The Commission has jurisdiction and management over the State's navigable and tidal waterways as well as certain lands granted to the State of California by the federal government under various Acts of Congress. Public and private entities may apply to the Commission for leases or permits on State lands for a variety of purposes. Land Management Division routinely conducts title research, boundary determination, appraisals, and leasing as part of the management of lands under its jurisdiction.

5. Washington D.C. Counsel \$100,000 Contract No. C2010-05

Enter into an Agreement to provide legal representation in Washington D. C. before Congress and the administration concerning federal oil and gas and public land matters. The Commission requires assistance with issues before agencies of the federal government, including the Department of the Interior, Bureau of Land Management, Minerals Management Service and the Department of Energy. The proposed contract services are neither efficient nor effective for the Attorney General to perform. The firm of Lobel, Novins, and Lamont has been selected to perform this service. Agreement shall be for two years subject to the availability of funds.

All agreements shall be consistent with State policies and procedures as specified in the State Administrative Manual and State Contract Manual. All agreements are subject to sufficient funding provided in the Commission's budget. Multi-year agreements are subject each year to certification of the availability of funds.

IT IS RECOMMENDED THAT THE COMMISSION:

1. Find that these activities are not subject to the requirements of CEQA pursuant to title 14, California Code of Regulations, Section 15060(c)(3) because the activities are not projects as defined by Public Resources Code Section 21065 and Title 14, California Code of Regulations, Section 15378.
2. Authorize the Executive Officer or Designee to execute Interagency Agreements in accordance with current State policies and procedures.
3. Authorize the Executive Officer or his Designee to solicit bids and proposals, award and execute contract with the qualified bidder in accordance with competitive bidding requirements of the Public Contract Code and current State policies and procedures.
4. Authorize the Executive Officer or Designee to enter into an Agreement for legal services with the firm of Lobel, Novins and Lamont in accordance with current State policies and procedures.
