### TERMINATION AND ISSUANCE OF A RECREATIONAL PIER LEASE

### LESSEES:

James P. Lennane and Susan K. Lennane

### APPLICANT:

Susan K. Lennane

## AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 9041 Lupine Way, near Rubicon Bay, El Dorado County.

### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier and two mooring buoys as shown on the attached Exhibit A.

### LEASE TERM:

Ten years, beginning December 23, 2008.

## **CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$500,000.

#### OTHER PERTINENT INFORMATION:

- 1. Applicant owns the uplands adjoining the lease premises.
- 2. On April 17, 2006, the Commission authorized a Recreational Pier Lease with James P. Lennane and Susan K. Lennane. The lease will expire on June 10, 2015. On December 23, 2008, the ownership of the upland parcel was transferred to Susan K. Lennane. Applicant is now applying for termination of the existing lease and issuance of a new Recreational Pier Lease.

- 3. The two mooring buoys were permitted by the Tahoe Regional Planning Agency on October 2, 2009.
- 4. The Applicant qualifies for a Recreational Pier Lease because the applicant is a natural person who owns the littoral land that is improved with a single-family dwelling.
- 5. **Termination of Existing Lease:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.
  - Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, sections 15060 (c)(3) and 15378.
- 6. **Issuance of New Lease:** Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).
  - Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.
- 7. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



Find that this activity is consistent with the use classification designated by the Commission for the land pursuant to Public Resources Code sections 6370, et seq.


## **AUTHORIZATION:**
