RECREATIONAL PIER LEASE

APPLICANTS:

Gordon C. Strachan, Trustee of the Gordon C. Strachan Qualified Personal Residence Trust of 2001 U.D.T. dated December 28, 2001, and Alan F. Strachan, Trustee of the Alan F. Strachan Qualified Personal Residence Trust of 2001 U.D.T. dated December 28, 2001

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 6760 West Lake Boulevard, near Tahoma, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier and two mooring buoys as shown on Exhibit A.

LEASE TERM:

10 years, beginning May 10, 2011.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$500,000.

Other:

The proposed lease contains a provision requiring the Applicants to obtain authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years of the adoption of a Final Environmental Impact Statement (FEIS) for the Lake Tahoe Shorezone Ordinance Amendments and approval of the amended ordinances. This is a continuation of the process the Commission used from approximately 1995 to October 2008, when TRPA adopted an FEIS and Ordinance Amendments supported by the FEIS. In September 2010, the U.S. District Court invalidated the FEIS and nullified the Amendments. When additional information is available, Commission staff will advise the Commission on any suggested modifications to the process used by the Commission pending resolution of the TRPA FEIS and ordinance issues.

OTHER PERTINENT INFORMATION:

1. Applicants own the uplands adjoining the lease premises.
2. On September 17, 2001, the Commission authorized a Recreational Pier Lease with Gordon Strachan and Alan Strachan. That lease expired on May 9, 2011. On January 3, 2002, the upland property was deeded to Gordon C. Strachan, Trustee of the Gordon C. Strachan Qualified Personal Residence Trust of 2001 U.D.T. dated December 28, 2001, and Alan F. Strachan, Trustee of the Alan F. Strachan Qualified Personal Residence Trust of 2001 dated December 28, 2001. Applicants are now applying for a new Recreational Pier Lease.
3. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who own the littoral land that is improved with a single-family dwelling.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined this activity is exempt from the requirements of CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370, et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

SIGNIFICANT LANDS INVENTORY FINDING:

Find that this activity is consistent with the use classification designated by the Commission for the land pursuant to Public Resources Code section 6370, et seq.

AUTHORIZATION:

Authorize issuance of a 10-year Recreational Pier Lease to Gordon C. Strachan, Trustee of the Gordon C. Strachan Qualified Personal Residence Trust of 2001 U.D.T. dated December 28, 2001 and Alan F. Strachan, Trustee of the Alan F. Strachan Qualified Personal Residence Trust of 2001 U.D.T. dated December 28, 2001, beginning May 10, 2011, for the continued use and maintenance of an existing pier and two mooring buoys shown on Exhibit A attached and by this reference made a part hereof; no monetary consideration pursuant to Public Resources Code section 6503.5; and liability insurance in the amount of no less than \$500,000.

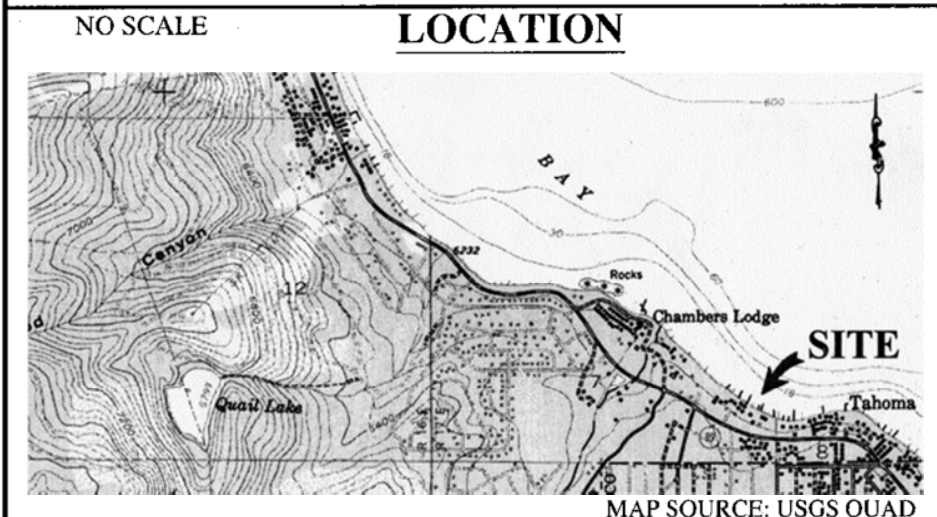
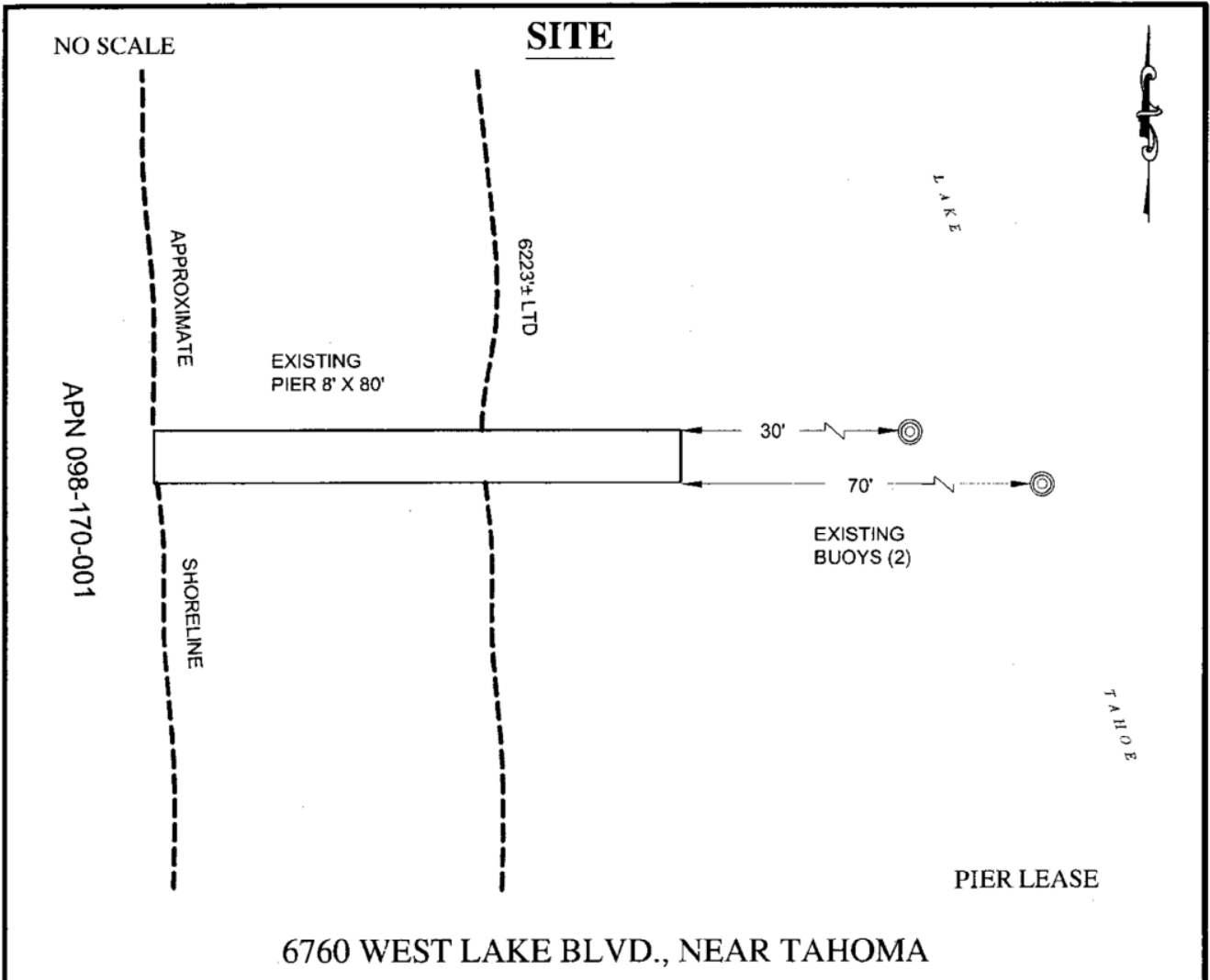
