**RECREATIONAL PIER LEASE**

**APPLICANTS:**

John P. Zimmermann and Bianca Zimmermann, as Trustees of the Zimmermann Family 2006 Trust, under Declaration of Trust dated December 1, 2006

**AREA, LAND TYPE, AND LOCATION:**

Sovereign land in Lake Tahoe, adjacent to 8769 Rubicon Drive, near Rubicon Bay, El Dorado County.

**AUTHORIZED USE:**

Continued use and maintenance of two existing mooring buoys as shown on Exhibit A.

**LEASE TERM:**

10 years, beginning April 20, 2010.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$500,000.

Other:

The proposed lease contains a provision requiring the Applicants to obtain authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years of the adoption of a Final Environmental Impact Statement (FEIS) for the Lake Tahoe Shorezone Ordinance Amendments and approval of the amended ordinances. This is a continuation of the process the Commission used from approximately 1995 to October 2008, when TRPA adopted an FEIS and Ordinance Amendments supported by the FEIS. In September 2010, the U.S. District Court invalidated the FEIS and nullified the Amendments. When additional information is available, Commission staff will advise the Commission on any suggested modifications to the process used by the Commission pending resolution of the TRPA FEIS and ordinance issues.

**OTHER PERTINENT INFORMATION:**

1. Applicants own the uplands adjoining the lease premises.
2. On April 20, 2000, the Commission authorized a Recreational Pier Lease with John P. Zimmermann and Bianca Zimmermann, as Trustees of the Zimmerman Family Trust, established on August 12, 1991. That lease expired on April 19, 2010. On March 10, 2008, the upland property was deeded to John P. Zimmermann and Bianca Zimmermann, as Trustees of the Zimmermann Family 2006 Trust, under Declaration of Trust dated December 1, 2006. Applicants are now applying for a new Recreational Pier Lease.
3. Applicants qualify for a Recreational Pier Lease because the Applicants are natural persons who own the littoral land that is improved with a single-family dwelling.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined this activity is exempt from the requirements of CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

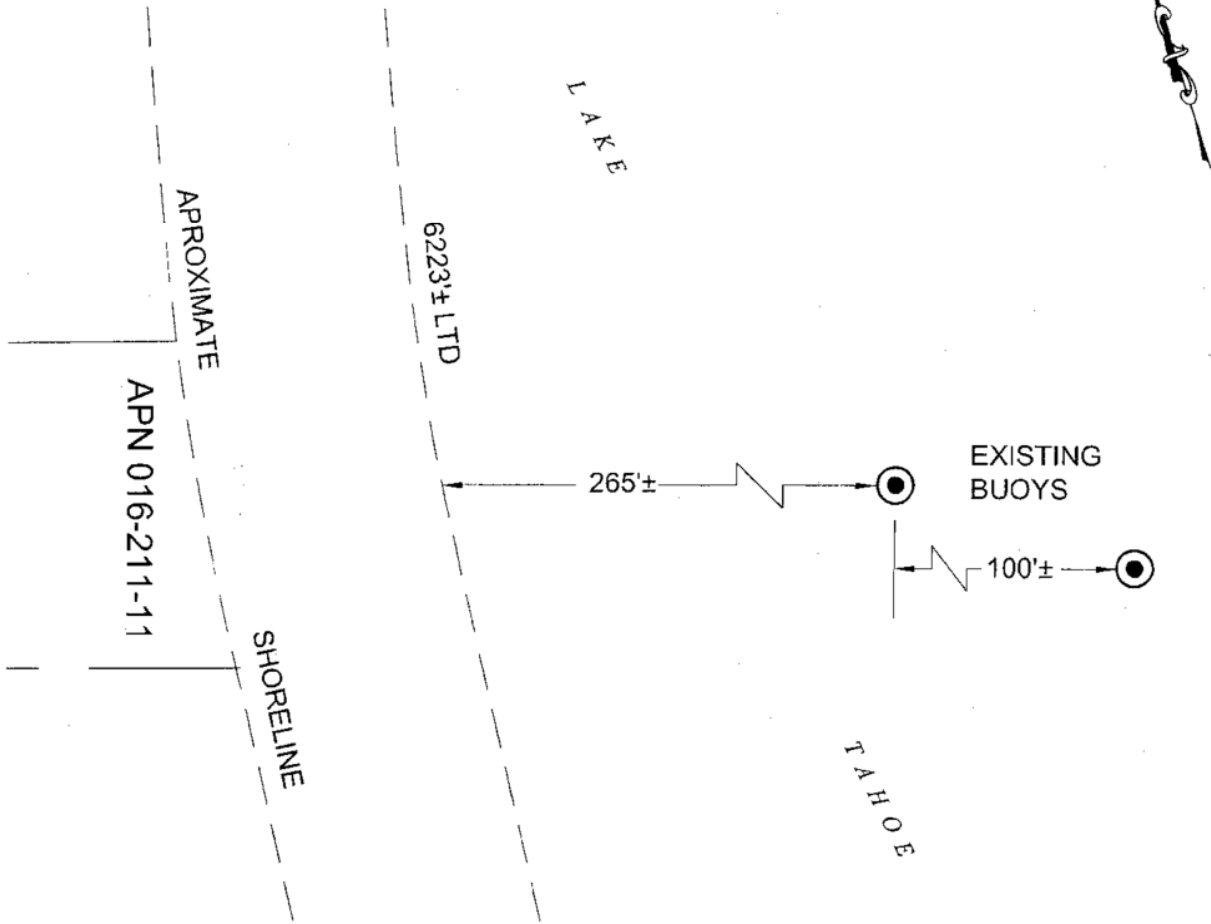
Find that this activity is consistent with the use classification designated by the Commission for the land pursuant to Public Resources Code sections 6370, et seq.

Zimmermann and Bianca Zimmermann, as Trustees of the Zimmermann Family 2006 Trust, under Declaration of Trust dated December 1, 2006, beginning April 20, 2010, for the continued use and maintenance of two existing mooring buoys shown on Exhibit A attached and by this reference made a part hereof; no monetary consideration pursuant to Public Resources Code section 6503.5; and liability insurance in the amount of no less than \$500,000.

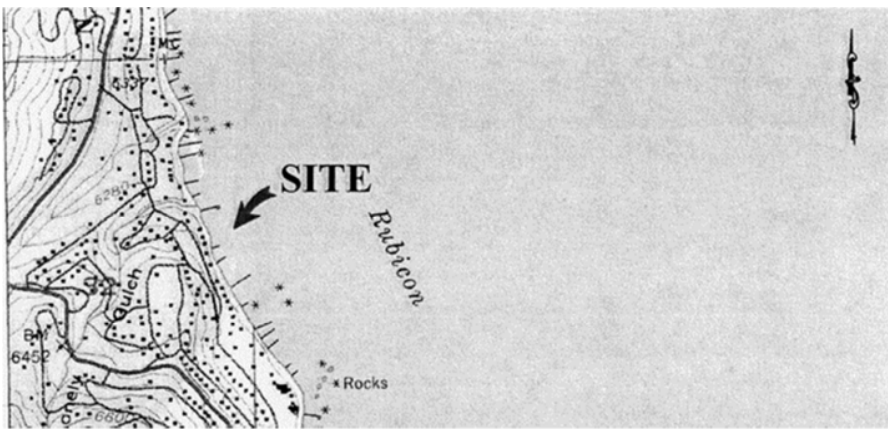
**SITE**

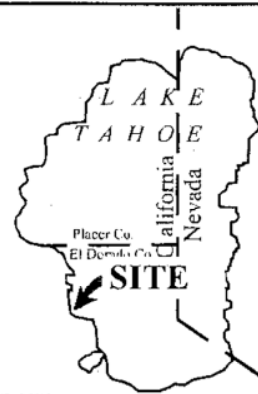
**LOCATION**
