### **CONTINUATION OF RENT**

## LESSEE:

Southern California Edison Company 2244 Walnut Grove Rosemead, CA 91770

# AREA, LAND TYPE, AND LOCATION:

Two parcels of school land within Section 36, Township 20 North, Range 8 East, and Section 36, Township 20 North, Range 9 East, SBM, near the town of Tecopa, Inyo and San Bernardino counties.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing 33 kV electrical transmission line.

#### LEASE TERM:

15 years, beginning August 25, 2001.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$200 per year, effective August 25, 2012.

#### OTHER PERTINENT INFORMATION:

- 1. Lessee has a right to use the lands adjoining the lease premises.
- 2. On October 1, 2002, the Commission authorized a 15-year General Lease Right-of-Way Use to Southern California Edison Company. That lease will expire on August 24, 2016. Southern California Edison Company inspects its electrical transmission lines annually. No violations have been reported.
- 3. The staff recommends that the Commission find that the subject continuation of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment,




